



Terms and Conditions for Alluma Trading Grand Prix

We are organizing the Alluma Trading Grand Prix (“**Competition**”) that is open to all Users having an active and ID verified account with Alluma (“**Participant**”). These terms and conditions shall apply to the Competition (“**Terms**”). By accessing this webpage, you confirm that you accept these Terms and that you agree to comply with them.

You are also bound by the Alluma Terms of Use, available at <https://www.alluma.io/terms-of-use.html>, in addition to the Terms set out herein. The Terms of Use and any other applicable guidelines, rules or standards posted in connection with the Competition are incorporated into these Terms by this reference as though fully set forth herein. Words capitalized and not defined hereunder shall have the meaning ascribed to them under the Alluma Terms of Use.

1. **Competition Period**: The Participants will be ranked in terms of the total number of tokens traded through their Account (*including both buys and sells*) in the Relevant Market through the duration of the Competition.
2. We reserve the right to disqualify any Participant that tries to subvert the Competition including by employing any unfair trading practices, disseminating false information, or otherwise unfairly breeding FUD or FOMO.
3. You acknowledge that the Competition is only a promotional event and participating in the Competition does not confer any rights or privileges, whether contractual or otherwise, on you. It is clarified that participation in this Competition does not constitute an offer or an invitation to an offer nor in any way does your participation in this Competition constitute a legally binding contract. Accordingly, we reserve the right to withdraw and/or alter any of the Terms at any time, without prior notice.
4. Participants may be individually contacted by Alluma and/or its representatives including but not limited to via e-mail addresses and contact numbers provided by the Participant. Alluma may also announce Winners’ names publicly. All Winners may be required to sign publicity releases. All Participants agree to receive communication in relation to the Competition including but not limited to phone calls, emails and text messages from Alluma and its representatives.
5. **Prize**:
 - a) The Prize shall be non-transferable, non-negotiable and Alluma reserves the right to change or substitute the Prize in any manner, at any time in any manner of its choosing.
 - b) Alluma reserves the right to withhold the Prize, at its sole and absolute discretion, and shall not be liable in any manner whatsoever.
 - c) Each Participant hereby releases and discharges Alluma from any and all claims and/or causes of action, known or unknown, arising from or relating to the Prize and/or their participation in the Competition.
 - d) Alluma shall not:
 - i. be responsible for any taxes or levies that may be applicable on/charged to the Winners under applicable law; or



- ii. provide any tax guidance or advice on this matter to any Participant and the Participant should engage independent consultants/advisors to seek any advice in this regard in their sole discretion.

6. No objections: Participation in this Competition constitutes Participant's full and unconditional agreement to Alluma's decisions in administering the Competition, which are final and binding in all matters related to this Competition, and shall not be subject to any appeal or contestation.

7. Co-operation Covenant: Participants may be required to sign, notarize documents as may be required by Alluma and provide any additional information that may be required by Alluma. Failure to comply with such requirements within the time period stipulated by Alluma may result in disqualification and selection of an alternate Winner.

8. Liability and Indemnity:
 - a) Alluma, its employees, officers, agents and directors are not responsible or liable for any damages, or economic or emotional loss related to the Participant's participation in the Competition. Participant releases Alluma, its employees, officers and directors from any and all claims, including claims that acts or omissions by Alluma, resulted in any damages, or economic or emotional loss related to the Participant's participation in the Competition.
 - b) Participant will indemnify Alluma and its affiliates, directors, officers, employees against all liabilities, damages, losses, costs, fees (including legal fees), and expenses relating to any allegation or third-



party legal proceeding to the extent arising from Participant's acts or omissions in relation to the Competition (including Participant's use or acceptance of any Prize and breach of these Terms).

9. Data Privacy: By participating in this Competition, each Participant agrees that their name may be announced publicly (for example it may be posted on the Alluma's website) to promote the Competition.
