### THE CUG WEB SITE IS UPGRADED

Our first web site was launched in July 1999, nearly four years ago. Like many sites created at that time, our designers, and to an extent ourselves, were still fascinated by the novelty of the Internet. This was reflected in our site where images, icons and "flash" technology took priority over infornation.

The result was a site that looked interesting, but where navigational features were not always clear. As more and more companies developed web sites, users ceased to be impressed by graphics; they wanted data and information, and they wanted it quickly. Clarity and speed of navigation therefore became dominant factors in the new design.

In talking to our producers, we found that the most common reason to visit our site was to access policy forms and endorsements. This feature is now prominent. Forms can be accessed either in the Policy Forms Section, or through the separate D&O and Professional Liability sections.

Our newsletter publications, "CUG.COMments" and "Prior & Pending," previously hidden in the site as subsections, now have their own main section. The newsletters are shown in a 'pdf' format, making them easier to read. Overall readability was also tackled in the upgrade. The original site used white text on a blue background; the new site has the more familiar dark text on a light background.

Some sections were dispensed with altogether. "Frequently Asked Questions," a staple of many sites, is gone. It's not convenient to read through a list of other people's questions to see if yours has already been asked. In the new site, if you have a question
