Introduction

We are pleased to announce our new primary V Directors and Officers Liability Insurance Policy that will replace our long-standing primary form ORUG-17. The new policy-ORUG-82-will greatly simplify our primary product and demonstrates Chicago Underwriting Group's continuing commitment to providing a market for primary D&O coverage.

- Subrogation against Insured Persons subject • to conduct exclusions
- Bilateral extended reporting period (ERP)
- Notice of circumstances allowed in ERP
- Only cancellable by insurer in the event of non-• payment of premium
- Claims brought by Securities and Exchange • Commission specifically included
- Insuring Clause A is unconditionally non-• rescindable
