

**Big Game Package Giveaway
WinStar World Casino and Resort**

Official Rules

1. WinStar World Casino and Resort is a governmental enterprise of The Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Beginning Sunday, January 6, 2019 through Saturday January 19, 2019, WinStar World Casino and Resort is giving away ten (10) packages and food & beverages valued at up to \$210,000 during the Big Game Package Giveaway promotion to invited patrons.
2. Patrons must be 18 years of age or older with a valid photo ID and must be a member of WinStar Club Passport with complete and accurate information to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of WinStar World Casino and Resort; employees of the Nation are prohibited from participating as set forth by any of the Nation’s policies, regulations or laws; anyone who is currently barred from any of the Nation’s Gaming Facilities; or any promotional sponsors.
3. Beginning 8:00am (CST) Beginning Sunday, January 6, 2019 through Saturday January 19, 2019 invited Patrons who are actively playing with their WinStar Club Passport card properly inserted into any participating electronic gaming device, will participate in a points race to win one of ten Big Game Packages.
 - a. The top ten patrons who earn the most points by actively playing any participating electronic gaming device with their WinStar Club Passport card properly inserted beginning Sunday, January 6, 2019 through Saturday January 19, 2018 will win one of the ten (10) Big Game Package giveaways.
 - b. The top ten patrons will be eligible to receive one Big Game Package that includes One (1) pair of tickets and all expenses paid trip to the Super Bowl 2019 game to be held on February 3, 2019 in at the Mercedes-Benz Stadium in Atlanta, Georgia.
4. The finale will be held on Saturday January 19, 2019 at 7 p.m.
 - a. Patrons must have rated play between 5:00pm (CST) and 7:00pm (CST) on Saturday January 19, 2019 and must be present to win.
 - b. The winner will be announced floor wide and will have 15 minutes to report to Regal.
 - c. Winner must accept prize. If not accepting of prize, the prize will be awarded to the next highest point earner.
 - d. If transferring the package to another individual, guests will only have 24 hours upon receipt of the package to get this information to Countdown Promotions.
 - e. Qualifying Patrons are invited to attend a come and go Mixer in Regal between 6:00 pm – 8:00 pm.

Upon any prize dispute resulting from game play, participants may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
