THE SEKURE REFERRAL PARTNER PORTAL



LOGGING INTO THE PORTAL


First time accessing the Portal



SUBMITTING YOUR FIRST STATEMENT


Use the **Upload Statement** button to enter the business contact information and upload their payment processing statement.

*Statements must meet the following qualifications.

- Collective volume must be a minimum of \$1,000.00.
- Must not be older than 3 months.
- Cannot be from a business on the Prohibited Merchants List (please see the full list in the Prohibited Merchants or Product Type section below)
- Must contain all pages and be legible
- Cannot be an existing client of Sekure Merchants Solutions or Sekure Merchants Solutions partners
- Cannot be from a merchant considered ineligible***



TRACKING COMMISSION


When you submit a statement through the Portal, a record of it will immediately appear on your Dashboard under the section titled **Statements**. Within 24 hours, the statement will be analyzed and, provided it meets the guidelines, you will see a record of it in the **Awaiting Payout** Tab. If the customer accepts the Sekure proposal, your second commission will appear...

Once the payment is made, your total will be reflected under the **Payouts** Tab. Payments are made weekly.




GETTING STARTED



Various types of businesses and the products they sell are deemed Prohibited Merchant Types and are not eligible for any of the platforms we provide.

Below you will find a detailed list of the business/product types we cannot work with.

Adult Material & Entertainment -

Includes adult or sexually related products, services, and media.

However, we can work with

Gentlemen's clubs

Business physically located outside the US / Offshore Merchants.

Cable Box Descramblers - Includes all devices or software designed to circumvent copyright protection techniques.

Charters & Tours - Excluding Day trips.

Check Cashing - Includes businesses primarily engaged in check cashing services.

Collection Agencies - Uncollectable Debt.

Counterfeit Goods - Includes "tribute items" or reproduction of original luxury goods (i.e. Gucci, Rolex, Louis Vuitton, etc.).

Credit Card Protection Services / Identity Theft - Includes all services designed to pay credit card balances due to unemployment or exigent circumstances.

Credit Repair Services - Includes all services and counseling purportedly designed to repair consumer or business credit.

Crowd Funding - (i.e. Kickstarter, GoFundMe).

Cruise Lines - Includes all regional and international cruise lines, charter services, and vacation packages involving cruises.

Drug Paraphernalia - Includes products generally used for the consumption or distribution of illegal substances.

Escort Services - Includes merchants with sexually oriented marketing content, offering dating, escort, and companionship services.

Gambling/Sports Forecasting -

Includes all gambling, wagering, lottery, fantasy sports, casino chips, and off-track betting activity. (Also includes Lottery Sales, Horse/Dog Racing and Skill Games).
