## **SUPREME COURT ADVOCATE PAUL CLEMENT TO RECEIVE 2013 BRADLEY PRIZE FOR OUTSTANDING ACHIEVEMENT**

*Third of Four Recipients of Tenth Annual  
Prizes Announced Today*

**Milwaukee, WI**—The Lynde and Harry Bradley Foundation announced today that one of the four 2013 Bradley Prizes will be awarded to **Paul Clement**, the former Solicitor General of the United States. During his tenure he represented the U.S. government in many cases involving national security and civil rights.

The award will be presented to Mr. Clement during the tenth annual Bradley Prizes ceremony that will be held at the John F. Kennedy Center for the Performing Arts in Washington, D.C. on **Wednesday, June 12**. Each award carries a stipend of \$250,000.

One of the preeminent attorneys of his generation, Paul Clement has argued more than sixty-five cases before the U.S. Supreme Court. He is a graduate of Georgetown University's School of Foreign Service and Harvard Law School. Mr. Clement served as a law clerk for Justice Antonin Scalia. He is currently a partner with Bancroft PLLC.

"Paul Clement has an impressive record of achievement," said **Michael W. Grebe, President and CEO of the Bradley Foundation**. "An advocate for freedom, he has argued many cases to preserve both individual liberty and national security."

The selection was based on nominations solicited from more than 200 prominent individuals across the country and chosen by the Bradley Prizes Selection Committee.

"Through the Bradley Prizes, we recognize individuals like Paul Clement whose accomplishments strengthen American institutions, in hopes that others will strive for excellence in their respective fields," said Mr. Grebe.
