This project has been undertaken as a partnership between Family Zone and CEDP within Family Zone’s COVID-19 offer for term 2 (which ends in early July). Family Zone’s intent is to support the CEDP community and demonstrate the strength and efficacy of the Family Zone platform to a major and influential Australian schooling institution. Should services continue beyond term 2 then the parties will agree commercial arrangements at that time.
