Knowledgebase article: State-Specific Information for Quarterly Wage on Disk(ette)

Overview of Steps

To produce quarterly wage reports on disk, follow the steps below:

- 1. Enter Employee Supplemental Information if your state requires it; see the article <u>Entering</u> <u>Employee Supplemental Information</u>. Sage ERP Accpac Payroll uses this information, along with the standard information from Payroll employee records, when files are created.
- 2. Use the Quarterly Wage on Disk(ette) feature under Payroll Government Reports to produce a quarterly wage report on diskette or hard disk. Read this article: <u>Producing Quarterly Wage on Disk(ette) or Hard Disk</u>.
- 3. To see if there are any special notes for your state, read this article.
- **Note:** The Quarterly Wage on Disk(ette) feature should be used with Sage Accpac ERP versions 5.6 and 6.0. Sage ERP Accpac versions 2012 and newer are integrated with Sage Payroll Tax Forms and eFiling by Aatrix, a service which prepares the files and reports. Notes and Instructions for Specific States

Alaska (AK)	The Quarterly Wage On Disk(ette) process will produce two files for Alaska: A header file called AKHDRyyq.CSV

	A details file called AKDTLyyq.CSV
	Where <i>yy</i> denotes the tax year and q denotes the quarter (for example, AKDTL143.CSV is the details file for year 2014, third quarter. If you are filing for just one company, you can submit only the details file.
Arkansas (AR)	The program will not support the Individual Out of State Wages and the Individual Out of State Wages State. The user will need to manually adjust the file for the employees that are impacted.
Florida (FL)	 On the Quarterly Wage On Disk(ette) window: To produce a test file (called FLQWTEST.xml), select the Test check box adjacent to the Tax Authority field. To produce a production file (called FLQWRPT.xml), clear the Test check box adjacent to the Tax Authority field. Ensure that the Contact Phone No. field (on the Transmitter Info I tab) contains only the 10-digit phone number, without any spaces or special characters.
	Before submitting your production file to the Florida Department of Revenue, we recommend that you submit a test file. The program can now produce a zero wage file to report that there was no employment for an employer per quarter. Zero wage files will be reported with one employee detail in the following manner:

	NOTE: A zero wage file can also be generated by using a selection criteria (selection list) that results in no wages found by the program, even though wage employees may exist in the database.
	For Florida Unemployment reports due on or after July 1, 2012, a recent law changed reporting requirements and adds a new field to the report specifically for private employers contracting to provide services to a governmental or nonprofit educational institution. The new field is to include the required Employee's Wages Paid this Quarter Under a Contract with an Educational Institution information.
	Employers with employees that fall into this category are required to manually enter the wage amount in the XML file after it is created. To modify the XML file, follow these steps:
	 Create your Quarterly Wage on Disk(ette) for Florida Unemployment. Once the XML file is created, double-click on the file to open it in the XML format in Notepad.
	 Scroll to the section in the file which begins with <employee>. Note that there's an <employee> section for each individual employee. Find the first employee whose wages require the additional detail.</employee></employee> Within the specified employee <employee> section, scroll to</employee>
	<educationalwages> and <totalwages>0.00</totalwages>.</educationalwages>
	5. Replace the 0.00 between the wages tags with the applicable amount for this employee.
	 Repeat this process for each employee who has the applicable Educational Wages.
	7. Save the file and submit following your standard process.

Georgia (GA)	Sage ERP Accpac Payroll does not support the N record (that is, the tax record).
Illinois (IL)	 After selecting the Tax Authority as Illinois Unemployment Tax the Monthly check box will appear next to the year field. The field has been added to allow for the monthly reporting option. Important notes about generating the file: If you check the Monthly check box you must enter the end date of month of that quarter. The 2 digit file sequence is set to "01". If you need to adjust for multiple files you will need to adjust this file sequence manually. The submission file must not contain duplicate Employer records. Appending a file can only be done for a different Employer and different set of employees.
Indiana (IN)	 Be sure that your employer number is formatted correctly in the Reporting ID field of the Federal And State Taxes window: 1. In the Tax field, select INSUTA. 2. In the Reporting ID field of the Basic Info tab, enter your employer number in this format: o 6 Numeric +1 Alpha or Space
Kentucky (KY)	 Be sure that your employer number is formatted correctly in the Reporting ID field of the Federal And State Taxes window: In the Tax field, select KYSUTA. In the Reporting ID field of the Basic Info tab, enter your employer number in this format: a. First two characters: Enter your 2-digit employer number prefix. If none, enter 00. b. Characters 3 to 8: Enter your 6-digit employer number. c. Character 9: Enter your employer suffix (must be an alphabetic letter). If none, leave it blank.
	 This format is required for the E record, location 173 to 181, as described in the magnetic media specifications for Kentucky. Starting January 1, 2014, the Kentucky Office of Employment and Training has added a surcharge tax rate to unemployment insurance (UI) for employers. Please note: Do not include the surcharge rate in the experience rate of the Kentucky Unemployment Insurance tax (KYSUTA). You must enter the surcharge rate in percentage format on the Qtrly Wage on Disk(ette) window when generating the Unemployment Insurance report.
Massachusetts (MA)	 For the Employer naming convention, Sage ERP Accpac Payroll uses the employer ID number from the Reporting ID field of MASUTA. For the Agent naming convention, use the Agent ID field on the Transmitter Info I tab to enter your Agent ID. If this field is blank, the Employer naming convention is used.

	3. Only the "Original" submission reason code is supported.
	You can only append to an existing Employer ID or Agent ID file if the ID numbers are the same and the files are generated on the same date. Otherwise, a new file will be generated.
Maryland (MD)	Be sure that your employer number is formatted correctly in the Reporting ID field of the Federal And State Taxes window:
	1. In the Tax field, select MDSUTA .
	 In the Reporting ID field of the Basic Info tab, enter your 10-digit employer's Account Number. The first two digits are zeroes. Omit hyphens and spaces.
Maine (ME)	Sage ERP Accpac Payroll supports only the layout formats described in the State of Maine's publication All Employers and Businesses Except Employee Leasing Companies.
	On the Transmitter Info I tab of the Payroll Quarterly Wage On Disk(ette) window, enter the Maine Payroll Processor License Number, as issued by Maine Payroll Department of Professional Financial Regulation.
	If you remit income tax withholding to Maine Revenue Services on a semi-weekly basis:
	 Select the Remit Payments Semi-weekly check box on the Employer Info I tab of the Payroll Quarterly Wage on Disk(ette) window. The Schedule 1 tab then appears.
	 Complete the information on the Schedule 1 tab, which simulates the published form "Schedule 1/C1 (Form 941/C1 – ME)" from Maine Revenue Services. For instructions, refer to those provided by Maine Revenue Services.
	The Quarterly Wage On Disk(ette) process produces a file for Maine called MEQRyy- q.txt , where yy denotes the tax year and q denotes the quarter (for example, MEQR14-3.txt is the file for year 2014, third quarter).
	Sage ERP Accpac Payroll does not support the ACH Debit information.
Michigan (MI)	Be sure that your employer number is formatted correctly in the Reporting ID field of the Federal And State Taxes window:
	• The UA Account number must consist of 10 digits in total. The first 7 digits are the Employer Number, the last 3 digits are the Multi Unit Number. The multi-unit number is three zeros unless you have requested a multi-unit number greater than 000.
	 Three checkboxes have been added – Final Report, Apportionment, and Amended.
Missouri (MO)	Be sure that your employer number is formatted correctly in the Reporting ID field of the Federal And State Taxes window:

	 In the Tax field, select MOSUTA. In the Reporting ID field of the Basic Info tab, enter your employer's Account Number. Omit hyphens and spaces. Be sure the entire number is entered in the Reporting ID field before you create the report on diskette or hard disk. An example of omitting hyphens; enter 345678012345678A for 345678-0-123-4567- A.
North Carolina (NC)	Sage ERP Accpac Payroll does support the N record (tax record).
North Dakota (ND)	 On the Transmitter Info II tab of the Payroll Quarterly Wage on Disk(ette) window: In the Provider field, enter the ID issued to you upon registration. The program will use this as its internal file name. In the Transport Media field select the Media Type applicable for your file.
New Jersey (NJ)	Enter the Magnetic Authorization number on Transmitter Info I tab of the Payroll Quarterly Wage On Disk(ette) window. If you submit multiple diskettes, each diskette must contain a complete set of employees, beginning with a header record and terminating with an ending record. Read the article <u>Producing Quarterly Wage on</u> <u>Disk(ette) or Hard Disk</u> .
New Mexico (NM)	 On the Employer Info II tab of the Payroll Quarterly Wage On Disk(ette) window: In the field to the left of the Code for WCA Fee field, select Deduction or Local/Other Tax. Your choice determines whether the Code for WCA Fee field will list the deduction codes or customized tax codes that you have created in Payroll. The file name is adjusted with the .TXT extension. Only the original file submission is supported. Note that Sage ERP Accpac Payroll will report any employee (not just New Mexico employees) who is assigned the code that you selected in the Code For WCA Fee field, and who has a WCA fee amount to report.
Nevada (NV)	 Be sure that your employer number is formatted correctly in the Reporting ID field of the Federal And State Taxes window: 1. In the Tax field, select NVSUTA. 2. In the Reporting ID field of the Basic Info tab, enter your employer's Account Number. Omit any decimal, hyphen, or check digit. Be sure the entire number is entered in the Reporting ID field before you create the report on diskette or hard disk. An employer number appearing on the pre-printed quarterly report as 0123456.00-7 must be entered as 012345600. The program produces a zero wage file to report that there was no employment for an employer for the quarter.

Ohio (OH)	 Sage ERP Accpac Payroll does not support the following: Third Party Administrator ID ACH Debit information Out of State Wages The file can only be created when the Employer and Transmitter have the same name.
Pennsylvania (PA)	 Sage ERP Accpac Payroll supports the following: File Upload and FTP. The original file and the amended file . A new .TAB file will be created for Original filing only. The .END file has been removed. No R or M indicators and no check digits in the State Unemployment Compensation Account Number. Do not drop the leading zeros if applicable. On the Employer Info II tab of the Payroll Quarterly Wage On Disk(ette) window: In the field to the left of the Code For Employee Assessment field, select either Deduction or Local/Other Tax. Your choice determines whether the Code For Employee Assessment field will list the deduction codes or customized tax codes that you have created in Payroll. The Third –Party Administrator (TPAs) are not be supported. Please refer to the state publication for all requirements.
Pennsylvania PSD (PA PSD)	 The Quarterly Wage on Disk(ette) function generates the magnetic media file for PA PSD taxes. You can create the file by doing the following: Click on Payroll >Government Reports and then double-click Qtr Wage on Disk(ette). From the Tax Authority dropdown select Pennsylvania PSD Tax. Enter any additional information in the appropriate fields. Click Process. Additional notes: Payroll supports the PA Standard format which is accepted by Jordan, Berkheimer, and Keystone. After selecting the Pennsylvania PSD Tax for the Tax Authority and the Quarter the Due Date field will change to the End Date of that quarter. This setting will create a file for the entire quarter selected. If you check Monthly, you will need to enter the End Date for the particular month in the quarter. For example, if you wanted to report for the first quarter of 2014 for the month of March, you would

	 If you have multiple work locations, specify each unique Employer PSD Code to generate a report for each location, and you can use the append option at the end of the file creation process to combine the reports.
	The Employer Tax Account Number is derived from the Reporting ID field in the Non-Resident PA Tax code.
	Foreign address is not supported.
	The Employer Total School District Only Payments is not supported.
Puerto Rico (PR)	 Sage ERP Accpac Payroll supports the Partial Wage Indicator. If the wages reported are for partial work PARTTIME. Check the Part-time worker shack bey in the Employee estup. Payr teb
	 worker check box in the Employee setup, Pay tab. If the box is unchecked it will report as Not available or full time work FULL TIME.
Texas (TX)	Sage ERP Accpac Payroll supports the C-3 Contribution Data reporting. The C-3 Data indicator and its associated fields will be populated in the report on diskette or hard disk. On the Employer Info II tab of the Payroll Quarterly Wage On Disk(ette) window:
	 In the Industry Code field, enter the 6-digit North American Industry Classification System code (NAICS) that best classifies the employer.
	• In the County Code field, enter the County Code of the county in which you had the greatest number of employees. Note that the program does not check for an incorrect County Code.
	 In the Outside County Employees field, enter the number of employees outside the county shown in the County Code field.
	Sage ERP Accpac Payroll does not support the Allocation List reporting. The Allocation List indicator (Record A, location 220) and its associated fields described in the magnetic media specifications will be left blank.
Vermont (VT)	Sage ERP Accpac Payroll supports Option 2 of the Vermont Internet Tax and Wage System Upload specifications.
