**Item 1.01 Entry Into A Material Definitive Agreement.**

On March 2, 2017, Flux Power Holdings, Inc. (the "Company"), and its shareholder, Mr. Scott Kiewit, amended an oral loan agreement originally entered into on February 1, 2017 and amended on February 15, 2017 (the "Loan Agreement") to increase the loan amount from \$350,000 to \$500,000 (the "Loan"). As of March 7, 2017, the Company has borrowed a total of \$500,000 from Mr. Kiewit and is in the process of negotiating the terms of the Loan which the parties intend to formalize in a written agreement. The Loan Agreement was initially reported on Form 8-K on February 9, 2017.
