
Key Box Corner

The SentriSmart app is a GKAR Member Benefit and a convenient tool for showing property, however your SentriCard is not obsolete. Always carry your SentriCard with you in case your app doesn't work in the area you are showing property.

The only way to assign a Lockbox to a listing or remove a Lockbox is with your SentriCard.

Keep in mind you cannot use the emergency renewal at a Lockbox with your SentriCard twice consecutively, so renewing it periodically at a card reader will help prevent possible issues.

Showing Time - The New GKAR Member Benefit

Showing Time is an optional software to assist you in scheduling showings for your listings and requesting feedback with delivery and sending options for both email and text. The current **eSchedule** link on each GKAR Member's listing in the MLS has been replaced with a Showing Time link.

Best Practices for Tax ID's in the MLS system

Here are some tips to help to ensure a link is created between your listing and the tax record located inside the flexmls system:

- Only a single Tax ID number can be entered into the Tax ID field. Additional
 parcels being sold together under the same MLS# can be entered into the
 Marketing Remarks field.
- Use the Taxes tab in the flexmls system to look-up the full and complete Tax
 ID so you can copy and paste the number into your listings as your entering
 property information.
- Some Tax ID's for properties taxed by the City of Portage end in the letter "O" and not a zero.
- All property in Kalamazoo County has a Tax ID that starts with "39", which is referred to as the County Prefix (Click <u>HERE</u> for a list of County & Municipal prefixes).
- Never enter a Tax ID with dashes or spaces.
- Always check your listing once it's been entered by clicking on the **Tax** link on the **Details** tab.

Including Personal Property in the Buy & Sell Agreement
