

Changes in Reciprocal Agreement Between MichRIC and Greater Lansing Association of REALTORS®

The Greater Lansing Association of REALTORS® (GLAR) has recently converted their MLS to FBS's flexmls system, the same vendor as MichRIC (formerly SWMRIC) uses. Now that GLAR members are using a flexmls system, MichRIC was able to enhance the Reciprocal Agreement with GLAR.

MichRIC and GLAR have signed a new Reciprocity Agreement which changes two things:

- 1. Includes reciprocal offers of compensation, whereas the previous Agreement only included login privileges to GLAR's MLS system for viewing listing information only
- 2. Allows GKAR Members to include GLAR members' listings in their search criteria in our flexmls system

You no longer need to login to GLAR's MLS system to search for property listed by their members. If you would like to include GLAR listings in your search criteria, use the **MLS of** field at the top of the criteria list to select MichRIC and GLAR in the Quick and Map search and the **Data Sharing** field in the Address and MLS# search.
