#### Summary of 2016 GKAR Professional Standards Cases

There were nine professional standards hearings in 2016: five ethics hearings (including one appeal) and four arbitration hearings (including two appeals). There were nine citations issued. The articles of the Code of Ethics found in violation were Articles 1, 2, 9, 11, and 12. ### A New Ethics Cycle Has Begun and GKAR Has You Covered

Every two years NAR requires you complete 2.5 hours of NAR approved ethics training. The current cycle is January 1<sup>st</sup>, 2017 - December 31<sup>st</sup>, 2018. Failure to complete your training during any cycle will lead to suspension of membership.

To help you meet your ethics requirement, all Course 1800 Continuing Education courses offered at GKAR will also include 2.5 hours of NAR approved ethics training, and there are five opportunities being offered in 2017 at no cost to you, compliments of your Board of Directors.

#### Listing Syndication Through ListHub Coming Soon!

We have been working to offer GKAR Members free listing syndication through ListHub. Members already utilizing ListHub will not have to do anything and their accounts will not be impacted. This offering is for Members that do not currently use ListHub and would like to syndicate their listings to 130+ websites. Watch for specific details on sign-up and training opportunities.

## Avoid Possible MLS & Ethics Violations When Accessing a Property...Follow the Showing Instructions and Know The Rules!

In addition to possible serious violations, the following rules are for your safety and the safety of others:

- Follow the Showing Instructions on the listing before accessing the lockbox on a property.
- Never allow another person (this includes your clients) to use your SentriCard under any circumstance; fines can be up to \$1,000.
- Never write your PIN on the card, attach it to, or keep it with your SentriCard; Members have been fined \$250.
- Report your SentriCard as lost or stolen to the MLS Department within 48 hours so the card can be deactivated.
- Do not allow your clients to access a property or remain on the property without your presence the entire time;
- View the complete GKAR Policy Manual.
- <u>View the 2017 Code of Ethics and Standards of Practice of the National Association of REALTORS®</u>.

If an individual, such as an assistant, a staff member at a brokerage, or a non-GKAR member needs to access a listed property, a 1-Day Code can be issued. For your convenience SentriLock Support can generate 1-Day Codes at the request of the listing broker or agent, 1-Day Codes can be generated through SentriLock's mobile website at <a href="mailto:m.Sentrilock.com">m.Sentrilock.com</a>, or by accessing the full website at <a href="www.Sentrilock.com">www.Sentrilock.com</a>.

Unlicensed assistants and non-GKAR Members may be eligible to lease a SentriCard from GKAR for a fee. If you have questions about eligibility and cost, please contact the MLS Department at (269) 382-1985 or email SamB@gkar.com.
