SentriSmart now has new Help pages that can be accessed through the app at any time. To view these pages, tap the information icon on any page. A user can now update account notifications in the app as well. Receive notifications when account information does not meet SentriLock's security requirements. When a notification is received, change the account information in SentriSmart or select "Remind Me Later" to receive a new notification the following week.

## Fallthrough Date vs. Expiration Date

When a property changes from Pending to Active, a fallthrough date is required in flexmls. This is the date the property was placed back on the market. The date that needs to be recorded is the date of final signature on termination documents. The Expiration date of the Listing Agreement does not change, unless appropriate documents were signed.

MichRIC has approved two new products that will be offered to Members, at no cost. AgentSquared and RE Technologies will appear as options in **Products** on the MLS. What are these products?

#### AgentSquared

Provides the ability to instantly build websites. They offer marketing automation for real estate agents and brokers, this ranges from websites to social media posts. #### RE Technologies

Offers helpful real estate articles directly to your email at the frequency of your choice. These articles contain business tips and tricks on technology and real estate practices.

### **Changes to Water Amenities Requirement**

Water access and amenities must now be within one mile or less from the designated property. Anything greater than one mile is to be marked "No" in the field **Water** Access.
