Key Box Corner

Is the SentriSmart App a good choice for you?

If you've just discovered your SentriCard has expired and you have a showing, you can use the SentriSmart app to generate an Access Code to open the key compartment. Listing Agents no longer have to wait for the Showing Agent to renew their SentriCard for confirmation you showed their listing because a Showing Notification is sent to the Listing Agent when you generate an Access Code for their lockbox.

You can use the SentriSmart app to quickly generate One Day Codes and email or text them to the Showing Agent directly from the app.

Don't worry, your SentriCard isn't obsolete. You'll still need to use it every time you assign a lockbox to your listing and when releasing the shackle to remove a lockbox from a listing.

The purpose is to bring awareness that cyber-crimes are rapidly growing and could potentially impact your clients' real estate transaction. Entering and Changing Listings on Time

With such a busy market, up-to-date information is critical for agents and updating the Status in a timely fashion is required. Follow these guidelines to stay in compliance with MLS Policy to ensure cooperation in the MLS.

- New Listings must be entered into the MLS no later than <u>48 hours</u> after the seller's signature on the Listing Agreement.
- Withdrawn and Cancelled status must be added no later than <u>2 business days</u> after the seller's signature on an authorizing document.
- **Pending** must appear on the listing within <u>2 business days</u> of a signed Sales Agreement.
- Sold must be marked on the listing in the MLS no later than <u>48 hours</u> of closing.

Guidelines to Remember When Accessing a Property for a Showing

Avoid serious violations; these rules are for your safety and the safety of others:

- Follow the Showing Instructions on the listing before accessing the lockbox.
- Never allow another person (this includes your clients) to use your SentriCard under any circumstance; fines can be up to \$1,000.
- Never write your PIN on the card, attach it to, or keep it with your SentriCard; Members have been fined \$250.
- Report your SentriCard as lost or stolen to the MLS Department within 48 hours so the card may be deactivated.
- Do not allow your clients to access a property or remain on the property without your presence the entire time.
- View the complete GKAR Policy Manual.
- View the 2017 Code of Ethics and Standards of Practice of the NAR.

If an individual, such as an assistant, a staff member at a brokerage, or a non-Member needs to access a listed property, a One-Day Code can be issued. For your convenience SentriLock Support can generate One-Day Codes at the request of the listing broker or agent, One-Day Codes can be generated through SentriLock's mobile app, or by accessing the full site at <u>www.SentriLock.com</u>. Unlicensed assistants and non-Members may be eligible to lease a SentriCard from GKAR for a fee.
