The MLS has continued to make updates to the flexmls Pro App making it easier to update listings on the go. Now, they have made updates to speed up searching the MLS for properties. From viewing the map to filtering results, the app is improving for both agents and clients.

Listing Setup on Showing Time

Showing Time added a feature for listing agent accompanied showings. If the client would like the listing agent to be present during all showings, it is easy for the listing agent to set this up on Showing Time.

Listing agents may open the property on Showing Time and find **Is this an agent accompanied showing?**, select **Yes**. When **Yes** is selected, the agent will be the first notified of showing requests, whether or not the client has been added to the notification list.


