Legal Update Versus Code of Ethics

Legal Update is a 2-hour, annual requirement of the State of Michigan. It is a course that must be taken in order to stay in compliance with License Law. These two (2) hours (taken every cycle year) make up six (6) of the 18 total hours required to renew your license at the end of the cycle, October 31st, 2021. These hours are not to be confused with NAR's Ethics requirement, that follows a separate cycle and is enforced by your Local Association. <u>Click here for more information on the Code of Ethics</u>.

Room Tab Updates

MichRIC and flexMLS are working to achieve Platinum level in the RESO Data Dictionary. It is a NAR requirement that MLS's reach RESO standards. In an effort to reach Platinum, fields will be adjusted in the Room Tab. Room Tab Length and Width fields will become numeric only fields, numbers may be entered as xx.xx.

Master Tax IDs in the MLS

Tax ID violations continue to be the most common GKAR violation. Here are some tips to master Tax IDs in flexMLS. Ensure a link is created between your listing and the tax record located inside the MLS system:

- Use **Full Tax Search**, in the MLS, to look-up the full and complete Tax ID. Copy and paste the ID into your listings as you're entering property information.
- Tax IDs may not contain dashes or spaces.
- Only a single Tax ID number may be entered into the Tax ID field. Additional parcels being sold together under the same MLS# can be entered into the Marketing Remarks field.
- Tax IDs in the City of Portage might end in the letter "O" rather than zero.
- All property in Kalamazoo County has a Tax ID that starts with "39", which is referred to as the County Prefix. Click HERE for a list of County Codes and Kalamazoo Taxing Authority Codes.
