Michigan Seller Disclosure Act

The form has gone through several revisions, however, the constants remain that:

- The licensee should not complete any portion of the form on behalf of the owner,
- The majority of residential transactions will require the form.

Review of MLS Policy Changes in 2019

In 2019, the MLS Committee continued to review and update MLS Policy to ensure the continued accuracy of MLS data and related products. Here are the policies and their updates that took place in 2019.

Section 1.2.10 Marketing Remarks: k. Statements that shift or attempt to shift responsibility for data accuracy to the buyer's agent (*Amended* 06/19)

Section 21.15 Supra Key Borrowing: If a Supra Key has not been returned within five (5) business days; is considered lost or stolen; or is returned damaged or unusable, a 250 replacement fine will be charged to the member that borrowed the Supra key. If a Supra Key is returned and operational within thirty (30) days, the fine will be waived, less 10 per day, from the date the replacement fine was charged. Agents charged a replacement fine will be suspended from borrowing Supra keys until the fine has been paid. (*Amended 02/19*)

Rapattoni MLS Free Trial Finished

The Rapattoni MLS free trial ended on December 31st, 2019. Those interested in switching to Rapattoni MLS may do so with no additional fees. Switching to Rapattoni MLS only will disable all but the Add/Change features in flexMLS. If you would like to use both flexMLS and Rapattoni MLS, an additional fee of \$21.00 must be paid quarterly and in advance.
