The following resolution was offered by Board Member Willie Rack and seconded by Board Vice-Chairwoman Jennifer Vidrine:

RESOLUTION

A resolution adopting Special Rules of Order for the LHC Board of Directors related to the discussion of agenda items; and providing for others matters in connection therewith.

WHEREAS, the Louisiana Housing Corporation ("LHC" or "Corporation") was created by and pursuant to the Louisiana Housing Corporation Act contained in Chapter 3-G of the Louisiana Revised Statutes of 1950, as amended (R.S. 40:600.86 through R.S. 40:600.111); and

WHEREAS, pursuant to La. R.S. 40:600.90(F), bylaws have been adopted for the governance and internal organization of the Corporation, and said bylaws dictate that Robert's Rules of Order Newly Revised shall govern the Board in all cases to which they are applicable and in which they are not inconsistent with the bylaws and any special rules of order the Board may adopt; and

WHEREAS, the Board of Directors of the LHC, as the governing body of the Corporation and as public servants to the citizens of the State of Louisiana, believes it necessary to conduct meetings in a democratic, orderly, and expeditious manner, and now deems it appropriate to adopt special rules of order governing the discussion of agenda items at its meetings.

NOW THEREFORE, BE IT RESOLVED by the Board of Directors of the Louisiana

Housing Corporation (the "Board"), acting as the governing authority of said Corporation:

SECTION 1. The following Special Rules of Order are hereby adopted:

- 1. Each board member will have a maximum of five (5) minutes to speak on each agenda item presented to the Board.
- 2. Each board member will have an opportunity to respond to any opposing comments for no more than three (3) minutes.
- 3. Each board member has the right to speak twice on the same agenda item; however, the total combined time for the first and second speech shall not exceed five (5)

minutes. A board member cannot make a second speech on the same agenda item as long as any member who has not spoken on the item desires to take the floor.

4. A member who has spoken twice on a particular agenda item on the same day has exhausted his or her right to debate the agenda item for that day.

5. A member cannot interrupt a speaker who has the floor.

6. Discussion must be confined to the merits of the pending agenda item.

SECTION 2. These Special Rules of Order shall govern the discussion of agenda items at all meetings of the Board, including, but not limited to, regular, special, and/or committee meetings.

SECTION 3. These Special Rules of Order shall be effective immediately upon the passage of this Resolution and shall remain in effect until such time that they may repealed, replaced, or amended by the Board through the adoption of a subsequent resolution.
