

## Louisiana Housing Corporation

The following resolution was offered by Board Member Donald B. Vallee and seconded by Board Vice-Chairwoman Jennifer Vidrine:

## RESOLUTION

A resolution authorizing the Louisiana Housing Corporation ("LHC" or "Corporation") to issue a Notice of Funding Availability ("NOFA") for the Louisiana State Emergency Solutions Grant funds in the amount of \$2,298,246; and providing for other matters in connection therewith.

WHEREAS, the Louisiana Housing Corporation is authorized to administer the State of Louisiana's allocation of Emergency Solutions Grant Program pursuant to Act No. 408 of the 2011 Louisiana Legislative Session; and

WHEREAS, the Federal Emergency Solutions Grant program funds are provided by the U. S. Department of Housing and Urban Development ("HUD") and administered by the Louisiana Housing Corporation; and

**WHEREAS,** HUD allocated Two Million, Two Hundred Ninety-Eight Thousand, Two Hundred Forty-Six Dollars (\$2,298,246.00) to the Louisiana Housing Corporation for federal fiscal year 2018; and

WHEAREAS, the Louisiana Housing Corporation has prepared a Notice of Funding Availability to award the Emergency Solutions Grant Program funding to units of local government; and

**NOW THEREFORE, BE IT RESOLVED** by the Board of Directors of the Louisiana Housing Corporation (the "Board"), acting as the governing authority of said Corporation, that:

**SECTION 1.** The Corporation is hereby authorized to proceed with the issuance of the Emergency Solutions Grant Notice of Funding Availability for fiscal year 2018 funds.

**SECTION 2.** The Corporation staff is authorized to prepare the forms of such notices, documents, and/or agreements as may be necessary to award the funding allocated by HUD.

**SECTION 3**. The Chairman, Vice Chairman, Executive Director, and/or Secretary of the Corporation are hereby authorized, empowered, and directed to execute any forms and/or documents required to be executed on behalf of and in the name of the Corporation, the terms of which are to be consistent with the provisions of this resolution.
