## **RESOLUTION**

**A resolution to authorize and direct the Single Family Staff of Louisiana Housing Corporation ("Corporation") to participate in June 2018 Homeownership Month; and providing for other matters in connection therewith.**

**WHEREAS**, HUD has designated June 2018 as National Homeownership Month and has encouraged its entitlement partners to participate; and

**WHEREAS**, the LHC Board of Directors and the LHC staff have expressed a desire to extend outreach activities; and

**WHEREAS**, previous LHC Homeownership Fairs were deemed a success, attracting several hundred people and heightening the awareness of LHC's housing role by providing multiple information booths, hosts and/or sponsors; and

**WHEREAS**, in recognition of the month of June 2018 as "National Homeownership Month" the Louisiana Housing Corporation ("LHC") seeks to extend its outreach efforts for Homeownership Month:

**NOW, THEREFORE, BE IT RESOLVED** by the Board, acting as the governing authority of the Corporation, that:

**SECTION 1.** A resolution is hereby approved authorizing the Corporation to participate in June 2018 National Homeownership Month.

**SECTION 2.** The Corporation staff is authorized to solicit sponsorships and booth rental fees from the LHC Finance Team, other housing organizations, and other local businesses in order to market and promote the events.




