With **BROWZ**, you can have all of these answers in seconds and rest assured that only compliant contractors and their employees will be allowed access to your site.

Collecting Time & Attendance Data

BROWZ Time & Attendance Tracking allows you to record when a contractor employee arrives and departs your facility. Contractors can be checked in and out manually by your gate entry staff, or BROWZ can integrate seamlessly with badging systems to collect and record this information automatically. Should you need to provide temporary access to your site, identification cards for contractors can be printed directly from BROWZ.

Employee Dashboard

The employee dashboard allows you to easily search for the employees of your contracted companies. From this dashboard you have access to time and attendance tracking functions including:

- Check in/out (process gate entry)
- View/print identification cards
- Display all on-site employees

You can also view employee-level information such as:

- Employee photo
- Employee certifications and trainings
- Entry/exit history

Real-time reporting

All data is available in real time. You can look up an individual employee to see their hours and if they are currently onsite, or you can view all the employees currently onsite. A point-in-time report can show you all supplier employees on-site at any given time in history.
