IOSH Qualifications

IOSH Managing Safely

4-day course. £495 pp.
Animated graphics cover understanding your responsibilities, investigating accidents and incidents, measuring performance. For Managers and Supervisors with H&S / environmental responsibility.

IOSH Legionella Approved

1-day course. £300 pp.
Covers understanding of the risk of Legionella and key control measures, the ACoP, the importance of risk assessment and maintaining comprehensive, up to date records. For those managing Legionella / water hygiene within commercial / domestic systems.

IOSH Managing Refresher

Ofqual Qualifications

HABC L2 Combined (Hot/Cold Water Systems + Cooling Towers)

1.5 day course. £450 pp.
Ofqual accredited course designed to help delegates with a basic knowledge of ACoP L8 and HSG 274 documents and expected standards of water-borne bacteria that causes Legionnaires' Disease.

HABC L3 Legionella Control for Responsible Person

Ofqual accredited level 3 includes essential knowledge around Legionnaires' Disease and how to manage a written Legionella control scheme and risk assessment process.

HABC L2 Legionella (Hot/Cold Water Systems)

Ofqual accredited level 2 for those managing hot / cold water systems designed to minimise risk of water-borne bacteria and comply day-to-day with ACoP L8.

Proqual L2 Waterborne Infections (Healthcare)

Ofqual accredited course for microbiology health effects of Legionella Pneumophila and Pseudomonas Aeruginosa and how this bacteria needs to be managed among vulnerable people in accordance with ACoP L8 and HTM04-01.

COSHH Awareness

How popular are our courses?
