

STRUCTURE FOR THE COMPLEXITY OF COMPLIANCE

IMPORT AND EXPORT REQUESTS

- Configurable web forms support request for export, import and re-export, sales and contracts, bids and proposals and hiring of foreign nationals
- Bidirectional communication between future license or agreement owner and compliance staff avoids duplicate data entry and clerical errors
- Create templates to save preparation and submission time of government application
- Seamlessly document and communicate decisions by compliance staff with stakeholders
- Authorize exports and imports using exemptions/ exception, general export permits or existing licenses or agreements

STATE DEPARTMENT AGREEMENT REQUESTS

- Triggers a requirement to generate a request for DOS agreements with one or more foreign licensees and sub-licensees
- Streamlines request information to flow directly into the agreement applications for electronic submission to DTrade via OCR's DOS Licensing™ module
- Dynamic web forms display the relevant fields and questions based on type of agreement, amendment or re-baseline
- Helps expedite processes of capturing relevant data such as scope and statement of work, valuations, type of export/import taking place under the agreement, foreign parties and the roles of each

FOREIGN TRAVEL REQUESTS

- Limit liability by addressing concerns before travel plans are approved
- Users can specify dates, nature of visits, and whether technical data exports, services, hardware or equipment transfer are involved
- Compliance personnel can identify license or export issues early in the travel cycle and help employees get specific authorizations needed from customs or licensing agencies
- Electronic review process avoids any duplicate data entry effort, reduces typographical errors, and increases productivity
- Generate automated travel approval letters with appropriate authorizations for employees handcarrying tools, equipment or technical data
- Manage follow-up actions such as post travel briefings, travel reports, and export records

VENDOR CERTIFICATION REQUESTS

- Procurement or Supply chain managers can request export vendor review and corporate certifications for suppliers and vendors to specific technologies, programs, or products families
- Maintain an auditable history of approved vendors which are authorized to perform specific activity

- Employees access the forms via a trade compliance defined portal page
- Use templates and existing data tables to minimize repeated entry
- Real-time collaboration between business and trade staff including Empowered Officials
- Full searching and sorting features to retrieve information
- Provide requestor with details of compliance determinations

MANAGEMENT REPORTING


- Audit trails provide complete information over the life cycle of a compliance request

INTEGRATION WITH THIRD PARTY SYSTEMS


