Export control compliance requires that companies determine the jurisdiction and classification of products, and must apply for an export authorization from either the Department of State (DOS) or Department of Commerce (DOC).

OCR's DOC and DOS Licensing modules are comprehensive solutions designed to address licensing requirements, provide a standardized workflow for application preparation and internal review, manage submission to the U.S. Government, as well as to track the progress of a submission until authorization is received. These solutions also provide a direct workflow for submitting Commodity Jurisdiction (CJ), advisory opinions, reporting, and other communications with the government.

OCR's solution increases administration efficiency by streamlining the application review process and improves the reporting and auditing functions.

COMMERCE DEPARTMENT LICENSING

The Commerce Department Licensing module enables corporations to implement a uniform and consistent corporate wide license application and internal review policy for the U.S. Department of Commerce (DOC).

While violations of the International Traffic and Arms Regulations (ITAR) may generate more headlines, the DOC actually issues up to four times the penalties of the DOS.

The DOC Bureau of Industry and Security (BIS) implements and enforces the Export Administration Regulations (EAR). BIS requires electronic submission of export authorizations for items on the U.S. Commerce Control List (CCL), through the Simplified Network Application Process – Redesign (SNAP-R) System.

OCR's DOC Licensing enables corporations to implement a uniform and consistent corporate wide workflow for internal creation and review of BIS-748 for export, re-export and the Commodity Classification Automated Tracking System (CCATS) applications for submission through SNAP-R.

STATE DEPARTMENT LICENSING

The Directorate of Defense Trade Control (DDTC) implements and enforces the export regulations under the International Traffic and Arms Regulations (ITAR) . DDTC requires electronic submission of export authorizations for items on the U.S. Munitions List, through the DTrade export licensing system

- Sign and submit forms electronically to DTrade without leaving the OCR system
- DOS Licensing seamlessly processes and submits DDTC forms
- Check DTrade submission status within the OCR system
 - Eliminates need to open DTSA Export License Status Advisor (ELISA) and My Application Ready Yet (MARY) system

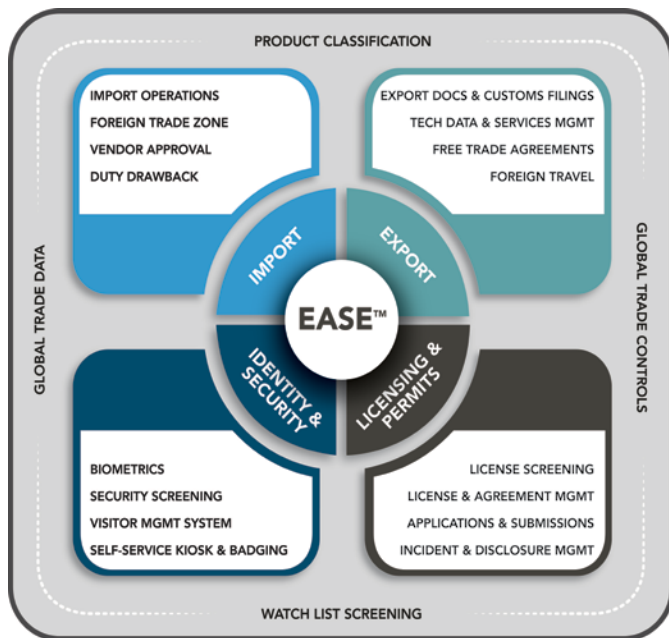
