Controlling Participants



If you leverage Zoom features, a Host can exert full control of a meeting/proceeding

- Control when a meeting is active 
- Control when participants have been admitted 
- Control audio (mute) 
- Control sharing of screens/files from participants 
- Remove participants if necessary 

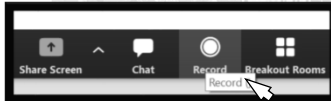

Zoom Recording for Court Use



- Enable Cloud Recording (we don't recommend using the "Local recording" option);
- From Meeting Settings under Email Notification enable "When a cloud recording is available"; the email account you use to login to Zoom will receive a notification when Zoom finishes processing the recording of a meeting, and that email will include a link that you can share with your Court Reporter to allow them access to the recording files;
- After the Host starts a meeting, the Host should select the Record option from the control bar to begin recording.



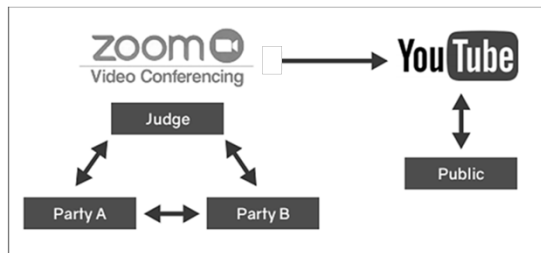

Public Access via YouTube



Michigan courts need a way to provide public access to court proceedings taking place in Virtual Courtrooms. This can be accomplished by outputting a live stream from Zoom to a Google/YouTube streaming channel.

Zoom connects the hearing participants together so that they can interact, and YouTube allows the public to watch what is happening in the Zoom meeting. The graphic below illustrates these connections.

- This setup takes time – there is a 24hr waiting period to enable live streaming capability after account setup

Public Access via YouTube



- The first time launching streaming from Zoom, you will be asked to grant certain permissions – this is a one-time process and should be accepted in order to proceed
- Once the streaming has started, the Host can close the YouTube browser tab and continue to manage the meeting.
- Streaming stops if you select Stop Streaming, or when you end the meeting.

Using Participant Control will stop “Zoombombing”

Zoom provides Encryption, but not “end-to-end” encryption by the technical definition; it is secure from outside influence, but Zoom employees technically have access to the data streams (though this is against policy)
