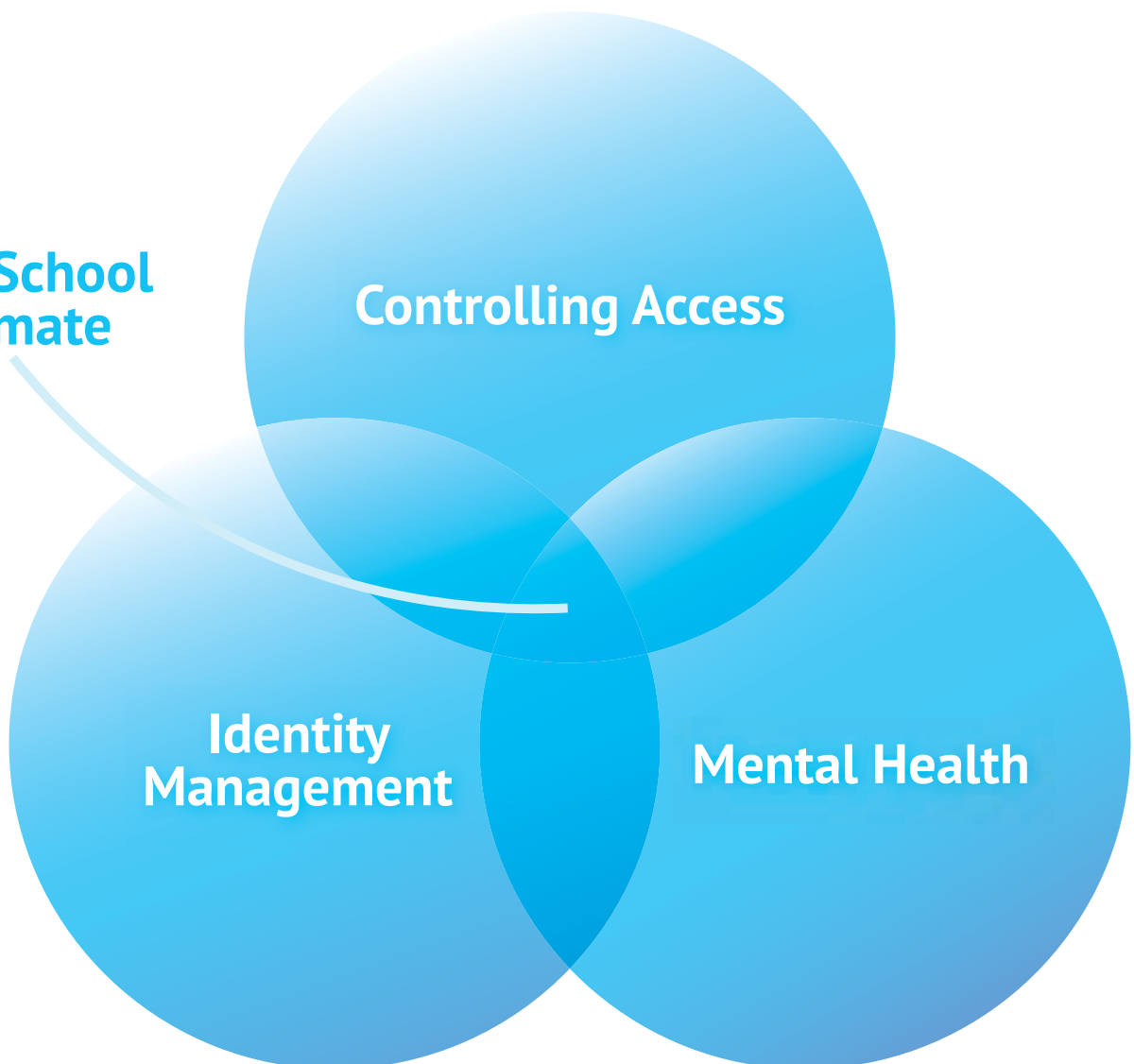

3. Large Group Entry- Safety Station

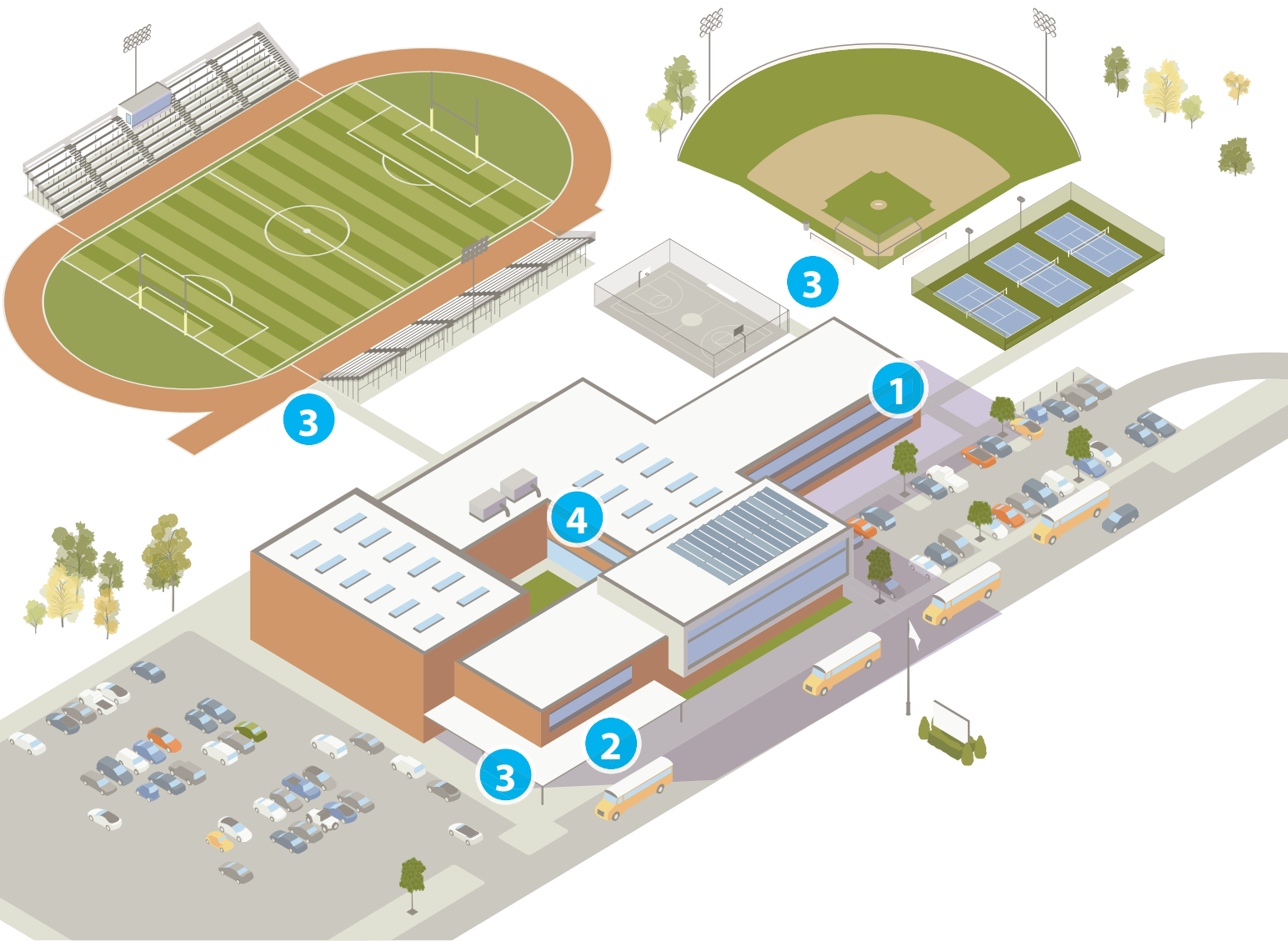
Take student attendance at the school entrance. Only enrolled students have access into the school. Stations can be moved and used for special events.
