

## Nylabone Dog Days and Sun Rays Photo Contest Official Rules

All eligible entries will be entered in the Contest. Incomplete entries will not be accepted. Entries are subject to verification. Submissions may be investigated and voided if fraudulent.   - (b) Photo must feature dog(s) owned by entrant.
  - (c) Photo must NOT be created or modified using photo editing software.
  - (d) Photo may be submitted in .gif, .jpg, or .png format and must NOT be smaller than 72dpi or larger than 3MB.
  - (e) Photo must be of good quality, not blurry, and not distort when displayed as page cover photo.
  - (f) Although not necessary for entry or to win, photo may feature Nylabone® product.
  - (g) Other than Nylabone® product, photo must NOT show any product branding of any kind.
  - (h) Photo may NOT be inconsistent with the positive images and/or goodwill associated with T.F.H.
