#### **United States - Overview**



#### **Under the CARES Act**

USPTO may toll, waive, adjust or modify any timing deadline under the 35 U.S.C. or regulations thereunder if the director of the USPTO determines that the emergency:

- (1) materially affects the functioning of the Patent and Trademark Office
- (2) prejudices the rights of applicants, registrants, patent and trademark owners, or others appearing before the Office; or
- (3) prevents applicants, registrants, patent and trademark owners, or others appearing before the Office from filing a document or fee with the Office

#### **United States – Extendable Deadlines**



- USPTO has determined that a person unable to meeting deadlines due to COVID-19 may be eligible for a waiver of certain deadlines
- Extensions for certain deadlines to pay fees or file documents which fall on/between March 27 and May 31
  - Deadlines extended to June 1 but:
    - Not automatic
    - Requires certification
    - Not for all deadlines
  - New order issued April 28 modifies previous order which allowed for extended deadlines to May 1, 2020

## **United States – Applicable Deadlines**



- Response to notice issued during pre-examination processing (small or micro entities)\*
- Response to Office Action or notice issued during examination\* or patent publication processing\*
- Issue fee
- Notice of appeal, Appeal brief, and Reply brief
- Appeal forwarding fee
- Maintenance fee (small or micro entity)
- Response to substitute examiner's answer, amendment when reopening prosecution in response to a PTAB decisions designated as including a new ground of rejection

## **United States – Non-applicable Deadlines**



- Certain filings for large entities
  - Response to notice issued during pre-examination processing
  - Maintenance fees
- Deadline for claiming priority to a provisional application
- Grace period after inventor's own disclosure
- 30-month deadline for entering the national stage of a PCT application
- Information disclosure statement submission timelines and associated fees

#### **United States – Procedure**



#### Extensions are not automatic

- Only available where the delay in timely filing was due to COVID-19 outbreak
  - "where someone associated with the filing or payment was personally affected by the outbreak" through reasons such as:
    - Office closure
    - Cash flow interruption
    - Inaccessibility of files
    - Travel delay
    - Personal or family illness
    - Similar circumstances which "materially interfered with timely filing or payment"

#### **United States – Procedure**



#### Extensions are not automatic

- Must make statement that the delay in filing/payment was due to COVID-19 outbreak which is submitted with the filing/payment to qualify for extension
- USPTO has released a form for making the above statement – "Statement of Delay Due to COVID-19 Outbreak (PTO SB-449)"

#### **United States - Other Relief**



- Certain filing deadlines for PTAB proceedings are also applicable where COVID-19 outbreak has interfered with ability to timely file
  - Request for oral hearing before the PTAB
  - Request for rehearing of a PTAB decision
  - Petition to the Chief Judge
  - Patent owner preliminary response in a trial proceeding
- Applies to deadlines between March 27 and April 30
  - The PTAB shall provide a 30-day extension of time
  - Permits the PTAB to further extend deadlines for IPRs/PGRs in view of the above extensions
- For other situations the USPTO invites the representative to contact the PTAB by phone or email

#### **United States - Other Relief**



- In addition to extensions, the USPTO has waived certain fees for revival or reinstatement due to abandonment because of the inability to timely reply due to COVID-19 outbreak
  - Limited to applications and reexamination proceedings which became abandoned on or before May 31, 2020 as a result of the COVID-19 outbreak
    - Applicable to petition fees under 37 C.F.R. § 1.17(m)
  - Must make statement regarding reason for delay submitted with the reply

# **United States – Prioritized Examination Pilot Program**




- Applicable to all patent applications of small or micro entity applicants with claims covering a product or process subject to U.S. FDA approval for use in the prevention and/or treatment of COVID-19
  - USPTO will grant prioritized examination without payment of typical fees associated with prioritized examination
    - Original utility or plant applications claiming the benefit of no more than one prior nonprovisional or international application
      - Made at the time of filing or with or after the filing of an RCE
  - Will endeavor to reach final disposition within twelve months, six months if applicant responds promptly to USPTO communications
  - Limited to first 500 applications filed under the pilot program
  - PTO/SB/450 form for submitting request



#### **United States - Other Relief**



- Temporary waiver to file plant patent applications electronically through EFSweb/Patent Center until further notice
  - Certain required documents to be submitted detailed in Office Notice



## **Europe – Overview & Applicable Deadlines**




- The EPO has issued four notices regarding the extension of deadlines for patent applications
  - Most recent notice issued on May 1, 2020
    - Automatically extends deadlines expiring on or after March 15 to June 2, 2020
  - Applies also to international applications before the EPO
- Applies to "extensions of periods" but not all deadlines are "periods" – many deadlines are encompassed by the extension but best to check with European Associate

## **Europe – Non-applicable Deadlines**



- Filing a divisional application
  - May only be filed while the parent application is pending no later than the day before the publication of the mention of grant of the patent
  - EPO appears to be still publishing the mention of grant on its usual timetable
- Filing an application on/before the date of a public disclosure
- Twelve-month priority period afforded by prior-filed applications in other jurisdictions
- "Double deadlines"
- Filing written submissions ahead of oral proceedings
- Renewal fees



## **Europe – Other Relief**



- Additional safeguards applicable for delays caused to dislocation in delivery or transmission of mail or "natural calamity" in the locality where the applicant resides, has a place of business in, or is staying
  - Must offer evidence that delay was due to disruption and that filing was performed as soon as possible after the disruption ended (with certain time limits laid out in the <u>Office Notice</u>).

## Canada

 Automatic extension of deadlines between March 16<sup>th</sup> and May 15th to May 18th

#### Australia

- Streamlined process for extensions of time
  - No explanation necessary must check box that you are unable to meet deadline due to COVID-19
  - Extension of up to three months is free of charge
  - In place until at least May 31st



#### **United States – Other Jurisdictions**



## <u>India</u>

 IPO closed until May 18<sup>th</sup> – automatic extensions for deadlines between March 23<sup>rd</sup> and May 18<sup>th</sup>

## **China**

- No special procedure for extensions
- May restore applications abandoned due to COVID-19 without cost

#### **United States – Other Jurisdictions**



## South Korea

- Automatic extensions for deadlines between March 31<sup>st</sup> and May 31<sup>st</sup>
  - More stringent limitations on applicable deadlines

## <u>Japan</u>

 No automatic extensions but option to include explanation for late response to remedy delay

#### **United States - Other Jurisdictions**



## **Taiwan**

 No special procedure for extensions but ability to request reinstatement for delay caused by COVID-19

## <u>Brazil</u>

Automatic extension of deadlines until May 15<sup>th</sup>
 2020

## **Takeaways**



- Extensions should be a last resort
- United States extensions:
  - Not automatic
  - Note which deadlines are non-applicable
- Foreign filings: consult with Foreign Associates for better understanding
- PCT applications relate to multiple jurisdictions and applicable relief may vary by jurisdiction
- Procedures are new and the limits of which have not been fully tested
