Here's our solution

We're covering an **alternative option** to opioids after impacted wisdom teeth removal.

Aetna Dental[®] coverage for EXPAREL[®] — an opioid alternative



We're the **first** and currently the **only** dental carrier to cover EXPAREL. EXPAREL is a nonaddictive, one-time injection at the surgical site that relieves pain for the first few days after impacted wisdom teeth removal. Since it takes special training to administer EXPAREL, we created a program to help increase EXPAREL awareness and use among oral surgeons in our network.

- EXPAREL may reduce the need to take opioid medicine.
- We cover EXPAREL under all fully insured Aetna[®] dental plans.

To reach our goal:

- We're continuing to expand our EXPAREL program to additional providers.
- We're creating a helpful resource on our provider search tool to show providers who offer EXPAREL.
