## Key Responsibilities

- Implementation and configuration of tools and subsequent testing, including a degree of independent checking of stochastic forecast results and writing automated testing scripts.
- Test cycle planning, implementation and management, including drafting high-level and low-level test plans and test scripts.
- Full functional system testing of newly developed tools and enhancements to existing tools using an agile approach, including aspects such as data integration, cross browser checking, accessibility testing and defect management to ensure timely delivery to specification/requirements.
- Working with our design and development teams on testing aspects associated with developing new tools and further development of existing tools
- Managing configuration projects from the client requirements phase through to Client Acceptance Testing and going live
