DECLARATION OF JASON G. CROWELL FILED ON BEHALF OF OSBURN, HINE, YATES & MURPHY, L.L.C. IN SUPPORT OF APPLICATION FOR AWARD OF ATTORNEYS' FEES AND EXPENSES

I, JASON G. CROWELL, declare as follows pursuant to 28 U.S.C. §1746:

- 1. I am a member of the firm of Osburn, Hine, Yates & Murphy, L.L.C. I am submitting this declaration in support of my firm's application for an award of attorneys' fees and expenses in connection with services rendered in the above-entitled action (the "Action") from inception through March 7, 2014 (the "Time Period").
- 2. This firm was liaison counsel for lead plaintiffs. The principal tasks undertaken by my firm included: acting as liaison counsel within the State of Missouri and reviewing and submitting Court filings; coordinating for lead counsel the preparation of all pleadings and motions; attending court hearings; and monitoring case activity.
- 3. The identification and background of my firm and its partners is attached hereto as Exhibit A.
- 4. The information in this declaration regarding the firm's time and expenses is taken from time and expense printouts prepared and maintained by the firm in the ordinary course of

business. Ted Osburn, Mike Murphy, and I are the partners who oversaw and/or conducted the dayto-day activities in the Action and reviewed these printouts (and backup documentation where
necessary or appropriate). The purpose of the reviews was to confirm both the accuracy of the
entries on the printouts as well as the necessity for and reasonableness of the time and expenses
committed to the Action. As a result of these reviews, reductions were made to both time and
expenses either in the exercise of "billing judgment" or to conform to the firm's guidelines and
policies regarding certain expenses such as charges for hotels, meals, and transportation. As a result
of these reviews and adjustments, I believe that the time reflected in the firm's lodestar calculation
and the expenses for which payment is sought are reasonable in amount and were necessary for the
effective and efficient prosecution and resolution of the Action. In addition, I believe that the
expenses are all of a type that would normally be charged to a fee-paying client in the private legal
marketplace.

- 5. The schedule attached hereto as Exhibit B is a summary indicating the amount of time spent by each attorney and professional support staff of my firm who was involved in the prosecution of the Action, and the lodestar calculation based on my firm's current billing rates. For personnel who are no longer employed by my firm, the lodestar calculation is based upon the billing rates for such personnel in his or her final year of employment by my firm. The schedule was prepared from contemporaneous daily time records regularly prepared and maintained by my firm, which are available at the request of the Court. Time expended in preparing this application for fees and payment of expenses has not been included in this request.
- 6. The total number of hours spent on this Action by my firm during the Time Period is 567.90. The total lodestar amount for attorney/paraprofessional time based on the firm's current rates is \$167,925.00.

- 7. The hourly rates for the attorneys and professional support staff of my firm included in Exhibit B are my firm's usual and customary billing rates for this type of work. My firm's lodestar figures are based upon the firm's billing rates, which rates do not include charges for expense items. Expense items are billed separately and such charges are not duplicated in my firm's billing rates.
- 8. My firm seeks an award of \$1,623.35 in expenses/charges in connection with the prosecution of the Action. They are broken down as follows:
