TO THE EXTENT NOT PROHIBITED BY LAW, THIS WARRANTY IS EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES, ORAL, WRITTEN, STATUTORY, EXPRESS OR IMPLIED. EXCEPT FOR THE EXPRESS WARRANTIES CONTAINED IN THIS LIMITED WARRANTY STATEMENT AND TO THE EXTENT NOT PROHIBITED BY LAW, WE DISCLAIM ALL OTHER WARRANTIES, EXPRESSED OR IMPLIED, STATUTORY OR OTHERWISE, INCLUDING WITHOUT LIMITATION, THE WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. OUR RESPONSIBILITY FOR DEFECTIVE GOODS IS LIMITED TO PRODUCT REPLACEMENT AS DESCRIBED BELOW IN THIS WARRANTY STATEMENT.

WHO MAY USE THIS WARRANTY?

Sill Dry Industries, LLC, located at 2800 Sterling Drive, Hatfield, Pennsylvania 19440 ("Sill Dry Industries"), provides this 15-year limited warranty to the original installer of a new SillDry™ sill pan product (hereinafter, the "Product(s)), who has successfully completed SillDry's Product Warranty Registration Form (located at www.silldry.com/warrantyregistration) *prior to the installation* of the relevant Product(s). This Warranty is transferrable to subsequent building owners within the Warranty's 15-year cover period, as long as the original installer properly registered the Product(s), as described above.

WHAT DOES THIS WARRANTY COVER?

This limited warranty covers defects in materials and workmanship of the Product(s), subject to Product warnings, for the Warranty Period as defined below. More specifically, Sill Dry Industries warrants that the Product(s) will conform to SillDry's published Product Specifications, when installed in substantial conformity with best practices in the construction industry and the Best Practices/Warnings set forth on SillDry.com, in a properly designed and constructed wall system, for a period of fifteen (15) years after the date of installation.

WHAT DOES THIS WARRANTY NOT COVER?

This limited warranty does not cover any damage due to: (a) transportation; (b) storage; (c) improper use; (d) failure to install the Product in substantial conformity with best practices in the construction industry and the Best Practices/Warnings set forth on SillDry.com, in a properly designed and constructed wall system; (e) modifications; (f) unauthorized repair; (g) external causes such as accidents, abuse, fire, lightning, hurricane, high winds, or other actions or events beyond our reasonable control; (h) the negligence, gross negligence or willful misconduct of the builder, general contractor, professional installer, or of any third party, including the building owner; (i) vandalism or attack by any party; (j) defects in the structure or a component of the structure (i.e., window, door or wall system) or selection and use of incompatible and/or inappropriate components which negatively affect the performance of the SillDry sill pan; (k) contamination from building site chemicals, or premature deterioration of the building materials; (I) nonstandard use or application of the SillDry Product(s); (m) improper building practices or design not in accordance with the application building code or industry standards, or any deviation from approved construction plans or project specifications; (n) foreign objects or agents, including the use of materials incompatible with SillDry Products; (o) UV exposure of the Product(s) in excess of that set forth in the SillDry Product Specifications; (p) improperly designed and/or installed building flashing systems; and/or (q) the reuse of the Product(s) in a second window installation. The SillDry Product(s) must be installed in substantial conformity with best practices in the construction industry and the Best Practices/Warnings set forth on SillDry.com, in a properly designed and constructed wall system.

WHAT IS THE PERIOD OF COVERAGE?

This limited warranty starts on the date of the original installer's installation of the Product(s) (if installed within one (1) year of purchase) and lasts for fifteen (15) years (the "Warranty Period"). The Warranty Period is not extended if Sill Dry Industries replaces the Product. Sill Dry Industries may change the availability of this limited warranty at its discretion, but any changes will not be retroactive.

WHAT ARE YOUR REMEDIES UNDER THIS WARRANTY?

This warranty is limited to product replacement. If the SillDry Product fails to meet the properties of the applicable SillDry Product Specifications, then Sill Dry Industries, LLC's sole liability will be to provide replacement Product. All Product replacement will be in the form of Product being manufactured at the time of replacement. No substitutions of other products or those manufactured by other manufacturers will be permitted. The Warrantee is responsible for any other costs associated with or arising out of the repair or replacement or any other correction. The Warrantee must reasonably cooperate with Sill Dry Industries or its representatives in their efforts to perform their obligations under this Warranty.

HOW DO YOU OBTAIN WARRANTY SERVICE?

To obtain warranty service, you must promptly call 215-634-9440 or email Sill Dry Industries' Customer Service Department at support@silldry.com during the Warranty Period to report any potential claim, no later than sixty (60) days after you discover the potential claim, and you

MUST provide Sill Dry Industries with proof of purchase and/or of installation of the SillDry Product(s). You must provide Sill Dry Industries or its representatives with a reasonable opportunity to inspect the building within sixty (60) days after Sill Dry Industries receives notice of your potential claim. At Sill Dry Industries' request, you must also provide access by Sill Dry Industries or its representatives to recovery of samples of the Product(s) from the actual installation in order to perform testing to determine whether or not the SillDry Product(s) failed as set forth herein.

LIMITATION OF LIABILITY

SILL DRY INDUSTRIES' LIABILITY UNDER THIS WARRANTY IS LIMITED TO PRODUCT REPLACEMENT. IF THE SILLDRY PRODUCT FAILS TO MEET THE RELEVANT SILLDRY PRODUCT SPECIFICATIONS AND THE TERMS OF THIS WARRANTY, THEN SILL DRY INDUSTRIES' SOLE LIABILITY WILL BE TO PROVIDE REPLACEMENT PRODUCT. THE REMEDIES DESCRIBED ABOVE ARE YOUR SOLE AND EXCLUSIVE REMEDIES AND SILL DRY INDUSTRIES' ENTIRE LIABILITY FOR ANY BREACH OF THIS LIMITED WARRANTY. SILL DRY INDUSTRIES' SHALL NOT BE LIABLE EITHER IN TORT OR IN CONTRACT FOR ANY DIRECT, CONSEQUENTIAL, INCIDENTAL, SPECIAL OR PUNITIVE DAMAGES OR LOST PROFITS, LOST REVENUE, OR LOSS OF USE, OR ANY BREACH OF ANY EXPRESS OR IMPLIED WARRANTY.

No representative, dealer or any other person is authorized to make, or makes, any warranty, representation or promise on behalf of Sill Dry Industries with respect to SillDry Products. No terms or conditions other than those stated herein or provided by law, and no agreement or understanding, oral or written, in any way purporting to modify this Warranty shall be binding upon Sill Dry Industries unless made in writing and signed by an authorized representative of Sill Dry Industries.

GOVERNING LAW/VENUE

This Limited Warranty shall in all respects be governed by the laws of the Commonwealth of Pennsylvania. Any action or proceeding seeking to enforce any provision of, or based on any right arising out of, this Limited Warranty shall be brought against any of the parties in the federal or state courts located in Montgomery County, Pennsylvania, and each of the parties consent to the jurisdiction of such courts in any such action or proceeding and waives any objection to such venue.
