How We Share Personally Identifiable Information Collected through our Websites and Mobile Applications

We do not "sell" your personal information as that term is commonly understood. When it is necessary for a business purpose, we share or disclose your personal information with a service provider, and we enter a contract with the service provider that limits how the information may be used and requires the service provider to protect the confidentiality of the information.

To Opt-out of the Sale of Your Personal Information

Nevada law gives consumers the right to direct a business not sell personally identifiable information the business has or will collect online about a consumer. If we require additional time, we will inform you of the extension period (up to an additional 30 days), and the reason for the extension in writing. If you have an account with us, we will deliver our response to that account. If you do not have an account with us, we will deliver our response by mail or electronically, depending on your preference.

Right to Access and Correction
