Aminophylline 1.8% / Arginine-L Monohydrate 3.6% / Sildenafil Citrate 0.25% in Hydrophilic Ointment

Version number: 1.0

Volume or quantity: 100 gm

Aminophylline, Anhydrous	1.8gm
L-Arginine Hydrochloride, USP (A1337)	3.6gm
Sildenafil Citrate, USP (S3092)	0.25gm
Propylene Glycol, USP (PR130)	1mL
Hydrophilic Ointment, USP	q.s. 100gm

\*Hydrophilic Ointment can be substituted with Vanishing Cream (B1285)

#### SUGGESTED COMPOUNDING PROCEDURES

1. Calculate the required quantity of each ingredient for the total amount to be prepared
2. Accurately weigh and/or measure each ingredient
3. Triturate the dry powders together and reduce particle size
4. Add sufficient amount of Propylene Glycol to the powders to form a smooth paste
5. Geometrically incorporate remaining base into paste in mortar or on ointment slab and mix until uniform
6. Transfer to appropriate container – click jar, syringe, tube or jar
7. Suggested Quality assessments:
  - a. color
  - b. texture
  - c. container
  - d. Label - auxiliary labels, storage, BUD, compounded medication

Store in air-tight, light resistant container, at controlled room temperature
