### SUGGESTED FORMULA

---

#### **Aromatic Elixir, USP**

Version number: 1.0

Volume: 1000 mL

---

Suitable Essential Oil(s)	XmL
Syrup, NF (SY105)	375mL
Talc, Powder USP (T1005)	30g
Alcohol	XmL
Purified Water, each q.s. to make	1000mL

---

Note: This formula is no longer available commercially.

Typical essential oils may include compound orange spirit – (mixture of orange, lemon, coriander, and anise).

#### **SUGGESTED COMPOUNDING PROCEDURES**

1. Dissolve the oil(s) in Alcohol to make 250mL.
2. Add the Syrup in several portions to step 1, agitating vigorously after each addition.
3. In the same manner add the required quantity of purified water.
4. Mix the talc with the liquid and filter through a filter wetted with diluted alcohol, returning the filtrate until a clear liquid is obtained.
5. Suggested Quality Assessments – follow pharmacy SOPs:
  - a. Color
  - b. Clarity
  - c. Aroma

Store in air tight amber plastic containers

Store at Room Temperature
