



SUGGESTED FORMULA

Cisapride 1mg/mL Syrup

Version number: 1.0

Volume: 100 mL

Cisapride, USP	0.1 g
Vehicle for Oral Solution, NF (Ora-Sweet™)	50mL
Sodium Bicarbonate 8.4%	q.s.
Vehicle for Oral Suspension, NF (Ora-Plus™)	q.s. 100mL

SUGGESTED COMPOUNDING PROCEDURES

1. Weigh Cisapride and place in glass mortar and pestle
2. Dry triturate to break down any clumps in the chemical
3. Add enough Ora-Sweet™ into mortar and pestle to form a “paste”
4. Triturate until all Cisapride is broken down and incorporated into liquid
5. Add more Ora-Sweet™ until pourable mixture.
6. Add enough Ora-Plus™ to bring to 95 mL
7. If necessary, add sufficient amount of Sodium Bicarbonate to bring to pH 7.
8. Add sufficient amount of Ora-Plus™ to bring to final volume.
9. Package and label.
10. Suggested Quality Assessments – follow pharmacy SOPs:
 - a. Weight to Volume calculation
 - b. Pourability
 - c. Settling/Resuspendability
 - d. Label - auxiliary labels, storage, BUD, compounded medication

Store in air tight amber plastic containers at Room Temperature.

Precautions should be taken to prevent cross-contamination and exposure of ingredients to the compounder and contamination of the preparation by the compounder. Wear appropriate protective equipment. Use safety enclosures (hoods) when weighing and mixing.
