

# Leaders@All Levels Fact Sheet

## Is there a deadline for booking my travel?

Yes, the deadline is Thursday, August 17<sup>th</sup>, 2017. For any airfare booked after this date, you will be responsible for additional costs created due to late booking.

## Can I bring a guest?

Yes, you can bring a guest from the US or Canada but you must attend the event with your guest.

## If I am attending the event alone and do not have a guest, can I use the extra money to upgrade the class of service?

LegalShield will not be responsible for any upgrades or substitutions and this will be at the cost of the associate regardless if you are bringing a guest.

#### What if I want to extend my trip outside of the standard dates?

Yes, within three days of standard arrival or departure dates.

## What type of airfare does PCQx3 Include?

PCQx3 includes standard airfare. Upgrades for PCQx3 vary by trip and will not necessarily include upgraded airfare.

#### How do we book our airfare?

## What if I have already booked airfare?

If you have already booked your airfare there is no need to contact Options Travel. When you receive the email from Options, select the "No, I have made my own arrangements" option. Once you return from the event, submit your request for reimbursement to <a href="mailto:recognition@legalshield.com">recognition@legalshield.com</a>.

#### What if I want to drive to the event?

LegalShield will reimburse the cheaper of the two whether it be mileage or airfare. Email Recognition for a quote.

## Do I need to book my own hotel?

Yes, we have properties listed on the L@AL microsite which is <u>connect.legalshield.com/leaders2017-travel</u> to assist you in your booking however if these are sold out you may book anywhere. We suggest checking with them periodically to see if there have been any cancellations.

# Can I book a hotel room outside of the overflow hotels, including Airbnb?

Yes, if you must stay at another property because the contracted hotel blocks are sold out, we will reimburse the standard room and tax.

# Why weren't hotel rooms held for the winners?

Unlike other PC Trips, this event was open to all associates. Additionally, many associates wanted to book and confirm arrangements well in advance of the qualification period ending. For these reasons, as published in booking guidelines, potential winners were advised to book in the contracted blocks and request reimbursement after travel.

#### How will we be reimbursed for our hotel?

After returning from Columbus please email your receipt along with your name and Associate number to <a href="mailto:recognition@legalshield.com">recognition@legalshield.com</a>. Please allow 7-10 business days for processing. Your reimbursement will be processed in the form of ACH deposit to your checking account on file.

PC Trip Qualifiers will be reimbursed 3-night standard room and tax.
