HOW IT WORKS

The identity document is simply placed on the scanner, or photographed on a mobile or tablet device, until the software confirms to the user that it has been correctly read. All scanned information is then processed and checked by our powerful software for accuracy and validity. The results and images are presented intuitively on screen for the user to accept the document, or, if in doubt, refer it to a manager or to TrustID at the click of a button.

All scanned information is stored in the system archive and can be easily retrieved for ongoing reporting, auditing and compliance needs. Records can also be exported to other systems or processes as required.
