PRIORITY SNAPSHOT: CONSTRUCTION

The construction industry accounts for 9 per cent of total employment in Australia, and includes the three sub-industries: Building construction (including both residential and non-residential), Construction services (including site preparation, installation service, completions services) and heavy and civil engineering construction.

The Australian Work Health and Safety Strategy 2012-2022 has identified the construction industry as a national priority, in an effort to reduce the number and rate of fatalities and serious claims.

Worker fatalities are relatively high: **3.0 fatalities per 100,000 workers**

Serious claims are high: 8.1 serious claims per million hours worked



Hit by falling objects a leading cause of fatalities: **27% of building construction fatalities**

FATALITIES COMPARISON

Fatality rates across the construction industry have remained relatively stable over the past 5 years, however has seen improvement over the past 10 years from 4.8 fatalities per 100,000 workers in 2007 to 3.3 fatalities in 2016.

KEY WHS STATISTICS

Within the construction industry, it was found that falls from height accounted for the largest recorded proportion of fatalities at 30%. This was followed by fatalities from being hit by falling objects at 15%.

The main cause of serious injury claims was muscular stress from lifting, carrying or putting down objects, representing 16% of all claims. Being hit by falling objects accounted for 8% of all serious injury claims.
