On the national level, August recess has been a time for representatives to spend time in their districts before returning to Capital Hill this fall

Workforce Diversity

- Legislation introduced in the US House of Representatives seeks to provide \$5 million/year in scholarships and stipensd aimed at increasing the # of students from underrepresented populations in PT and other allied health professions
- The bill has passed the House Energy & Commerce Committee; a vote by the full House could happen this fall
- Awaiting a companion bill in the Sentate
