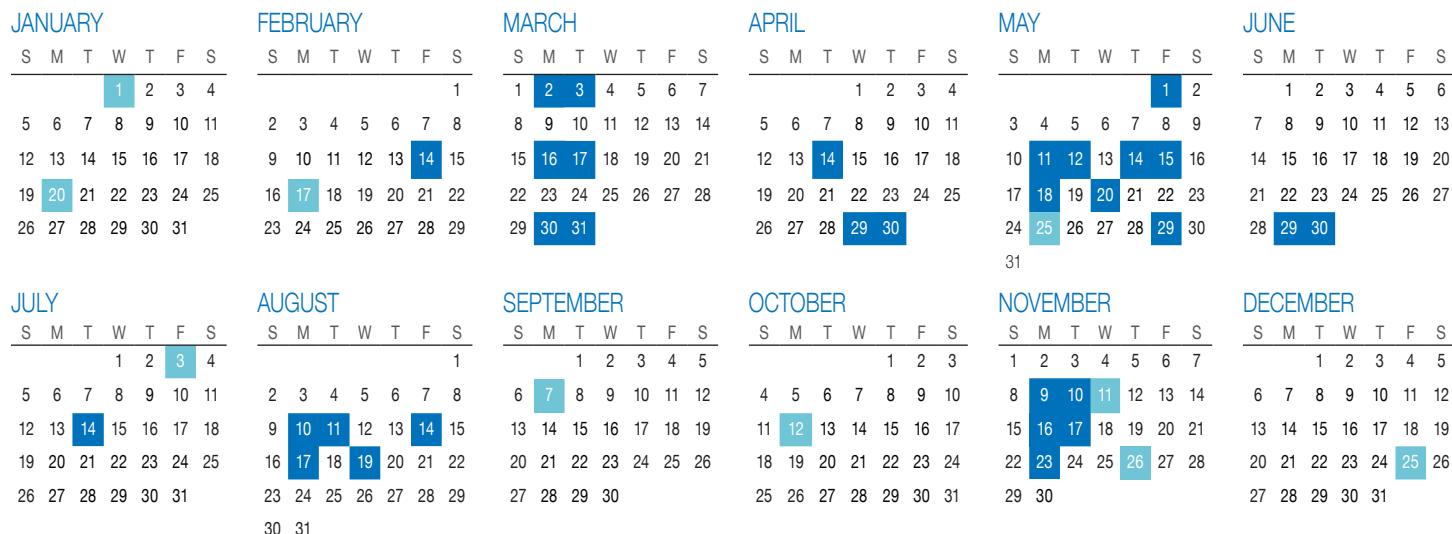

ADDITIONAL EDGAR FILING DATES – PUBLIC COMPANIES

Form 3: 10 days after individual becomes a reporting person or no later than the effective date of the registration for new Issuers

Form 4: 2nd business day after insider trade

Form 5: 45 calendar days after issuer's fiscal year end

Form 11-K: 180 days after fiscal year end

Form 13-F: 45 days after each quarter end

Form 20-F: within 4 months of Foreign Private Issuer's FYE

Late 10-K, Late 11-K, Late 20-F: Up to 15 calendar days after original filing deadline

Late 10-Q: Up to 5 calendar days after original filing deadline

Notice & Proxy: If Part III of your 10-K incorporates information from your proxy statement, file the definitive proxy statement by 120 days after FYE. If unable to file within that 120 day limit, file an amended 10-K to include the Part III information, also due by 120 days after FYE.

NT Filings: Within 1 business day of original filing deadline (Form 12b-25)

Schedule 13D: 10 days after the acquisition of more than 5% beneficial ownership

Schedule 13G (/a): 45 days after calendar year end
