As the pioneers of introducing the Reggio Emilia early childhood education philosophy in Sydney's Eastern suburbs, The Scots College opened its new Early Years Centre in Rose Bay in January 2013. The Centre specialises in the nurture and education of 3, 4 and 5 year old boys in a play-based learning framework informed by the Reggio Emilia philosophy whilst offering a longer day care option for working parents.

At Scots' Early Years Centre, each boy will be an active discoverer of his new and expanding world. The Reggio Emilia education philosophy models a partnership with children, teachers and parents in which learning occurs in a happy, fun, loving, caring and homely environment rich in opportunities for boys' discovery and learning.

Harnessing a boy's natural curiosity and energy, the educational day care program encourages each boy to explore and discover his world. Through the power of play, boys discover letters and numbers, words and counting, forming the foundations of literacy and numeracy.

In the Early Years Centre's supportive and active learning environment, every boy will learn to explore new ideas with confidence. The Centre's activities cater to growing boys' needs harnessing their natural curiosity, eagerness to learn and their love of communication with others. The Centre's facilities include an outdoor play area with soft fall areas, open and undercover play areas, sandpits and age relevant climbing and play equipment where boys can run, play and dance and explore their world and potential.

Scots' Early Years Centre offers world class opportunities with fully qualified specialist staff and the opportunity to secure long term enrolment at The Scots College guaranteeing the chance for your son to be a fine Scots boy.

Long Term Enrolment – Upon offer and acceptance of a place, the payment of the non-refundable Long Term Enrolment Fee allows for ongoing enrolment into The Scots College, Bellevue Hill campus (K-12).

Conditions of Enrolment

These conditions are to be agreed to by parents or guardians when they accept an offer of a place for a boy at the College.

Fees

1. We agree to pay to the College all fees for tuition, extra subjects, excursions, camps and the supply of goods and services to the student as determined by the College Council and as published in the Fees Schedule – Early Years Centre Rose Bay.
2. The College may refuse entry to, or terminate the enrolment of a student whose fees are TEN weeks' in arrears.
3. All fees are payable in advance and **four** full weeks' notice must be given in writing to the Coordinator of the Early Years Centre and the Admissions Office before any student is withdrawn.
 - 3.1 **Short-Term Enrolment:** Should a Short-Term Enrolment fail to give the required notice (**four** weeks) for withdrawal, we agree and understand that the refundable Entrance Fee is no longer refundable and will be retained in lieu of notice.
 - 3.2 **Long-Term Enrolment:** Should a Long-Term Enrolment fail to give the required notice for withdrawal, **four** full weeks fees in lieu of notice will be payable. Please note the Entrance Fee remains non-refundable and non-transferable irrespective of whether the student commences at the College or not.
4. We understand that no remission of fees, either in whole or in part, will be made if the student is absent due to illness, leave or suspension.
5. We authorise the school to incur expenditure on our behalf such as purchases of books, stationery and equipment, and to advance such fares from time to time as the College considers necessary.
6. We understand that the Principal may exclude a student if they consider that a mutually beneficial relationship of trust and cooperation between a parent/ guardian and the College has broken down to the extent that it adversely impacts on that relationship.
7. We acknowledge that the Principal may exclude a student if they consider that a mutually beneficial relationship of trust and cooperation between a parent/ guardian and the College has broken down to the extent that it adversely impacts on that relationship.
8. Requests for leave from the Early Years Centre Rose Bay must be applied for in writing to the Coordinator of the Early Years Centre.
9. We understand that students must follow conventional standards of dress and appearance in accordance with what the College believes is the expectation of the College community.
10. We accept the College's discipline policy contained in the Early Years Centre Rose Bay Handbook for Parents. We agree to support the administration of the College's discipline policy. In particular, we accept that the Principal may in his absolute discretion suspend or dismiss the student for breaches of rules of discipline.
11. We acknowledge that the College seeks to maintain an environment that is safe for all students and in which learning can take place.
12. We understand that the College requires parents to be actively involved in the College through attendance at parent-teacher interviews and parent forums, participation in courses offered by the College relevant to the student's education and assistance to the College in a voluntary capacity from time to time.
13. We understand that the College requires parents to observe College security procedures for the protection of students from direct contact with those outside the College during Early Years Centre Rose Bay opening hours and that we only make contact through the Early Years Centre Rose Bay reception.
14. We acknowledge that the student's personal property is not insured by the College, which does not accept any responsibility for loss.
15. We acknowledge that the College may from time to time collect personal information about parents and students which may be necessary for the College's functions or activities. We authorise the College to use and disclose information in such a manner as the Principal may deem appropriate for the purposes of the student's education, health, care, welfare or development.
16. Where relevant, we agree to provide to the College all current Family Court or other court orders relating to us and the student. We note that the College has a Privacy Policy dealing with the confidentiality of such information.
17. We understand that Academic reports, accessible through Pipeline, will be sent to the address notified by the parents or guardians. When parents are separated or divorced, reports will be sent to each parent (separate logins to be provided) unless there is an order of a court or an agreement which provides that reports are to be sent to one parent.
18. We acknowledge that we have fully disclosed any special needs (including but not limited to any medical, physical, learning or psychological needs) which the student has. Where any disclosed special needs change or where any special needs arise, we agree to notify the College immediately. We understand that if we have failed to disclose or not fully disclosed any material matter, either in the application form or subsequently, the College may, if the student is not enrolled, withdraw the offer or, if enrolled, terminate the enrolment without notice.
19. We also agree to complete the student's medical form accurately and provide annual updates for the Coordinator of the Early Years Centre.
20. We acknowledge the College requires, at the time of application, an Immunisation History Statement issued by the Australian Childhood Immunisation Register to be attached with the student's Application for Enrolment Form.
21. These Conditions of Enrolment apply to the Early Years Centre Rose Bay only and do not guarantee a place for the student at College.

General Conditions

6. If the student is ill or injured, necessitating urgent hospital and/or medical treatment (for example injections, blood transfusions, surgery) and if we are not readily available to authorise such treatment, we authorise the Principal or, in his absence, a responsible member of the College staff, to give the necessary authority for such treatment. We agree to pay all medical and ambulance expenses incurred on behalf of the student.
