1. If your scheduled day falls on a public holiday or if your child is sick, the daily rate will still apply.
  2. The Rate Per Day includes all meals.
  3. Casual requests for additional days may be accommodated, subject to availability. The daily rate will apply.
  4. A late pick up fee of \$5 applies for every minute (or part thereof) after 6:00pm.
- <sup>^</sup> Old Boys' sons and grandsons are entitled to a discount of 50 percent on The Scots College Entrance Fee, noting there is no discount offered on the Rose Bay, Early Years Centre Registration Fee.

All amounts are expressed in Australian dollars.

## Fee Payment

A bond will be payable prior to a child starting his attendance at Rose Bay, Early Years Centre. The bond will be equivalent to four weeks of attendance fees and will be applied at the end of enrolment to cover the last four weeks of attendance if all fees are up to date.

Attendance invoices will be rendered fortnightly in arrears.

## Method of Payment

Direct debit via Xplor. Families are to provide their bank account or credit card details on Xplor and ensure there is sufficient funds available on the direct debit date. A \$25 charge will be made for any dishonoured direct debit. Refer to the Direct Debit Schedule 2020 for the direct debit dates.

## Payment Terms

Where fees are not paid by the due date and there is no approved alternative arrangement for payment, a child may be refused entry until such a time as fees are brought up to date.

Fees not paid by the due date may be subject to external collection and/or legal proceeding and any costs incurred in this process will be billed to the family account.

If fees are in arrears by the equivalent of two weeks' worth of fees, enrolment may be terminated.

## Absences and Public Holidays

If a child is absent for any reason, or if the scheduled day falls on a public holiday, fees remain payable for the period of absence.

## Child Care Subsidy

The Scots College Rose Bay, Early Years Centre is recognised as an approved centre and is part of the Child Care Subsidy System (CCSS). Eligible families can apply for the Child Care Subsidy through the Australian Government Office of Family Assistance (Centrelink).

Families are to provide the Director of Rose Bay, Early Years Centre with Child Care Subsidy information including Parents' CRNs, Children's CRNs and Parents' date of birth. Without this information, subsidies from the Government will not be received.

Families intending to receive payments will be required to electronically sign a Complying Written Arrangement (CWA) via Xplor to be eligible for the Child Care Subsidy. A CWA is an agreement to provide care in return for fees.

## Withdrawal

Four weeks' notice must be given in writing to the Director of Rose Bay, Early Years Centre and the Admissions Office before any student is withdrawn.

All fee policies are subject to continuing College Council approval.
