

1. About Us

Jellypipe, available through the website jellypipe.com (hereafter “the Site”) is a cloud service provided by Jellypipe AG. Jellypipe AG (hereafter “Jellypipe”) is a company, established and registered in Switzerland, with registered office at Clarastrasse 21, 5442 Fislisbach, with VAT registration number CHE-468.722.953 VAT.

2. Agreement

Your usage of the Site is subject to your compliance with the terms and conditions set forth below. If you do not agree to these terms of use, do not use the Site. The information and content provided on the Site and your access of the Site does not create any relationship between you and Jellypipe.

Jellypipe may modify these terms and conditions at any time, and such modifications shall be effective immediately upon posting of the modified version on the Site. Your continued use of the Site shall be deemed your conclusive acceptance of the modified terms and conditions. However, contracts concluded on the basis of previous terms and conditions remain unaffected but you have to prove the terms which are applicable.

Orders placed by you are accepted and all contracts are made subject to these terms and conditions which shall prevail and be effective notwithstanding any variations or additions contained in any order or other document submitted by you. No modification of these terms shall be binding upon Jellypipe or any of its subsidiaries or affiliated companies (hereafter ‘Jellypipe’) unless made in writing by an authorised representative of Jellypipe.

The Site is available only in English and orders can be placed in English.

3. Usage of the service

Jellypipe offers the cloud service by choosing your Ordershop. You can use the services provided if you are of legal age to make a binding contract. In case you choose to work with our services using an account, it will be protected by a password.

You are responsible for maintaining the confidentiality of your account password, and you are responsible for all actions that are done under your account. You will immediately inform Jellypipe in case of unauthorized use of your account. Jellypipe cannot and will not be liable for any loss or damage, arising from your failure to protect your account and/or your password.

You are solely responsible for 1) providing true, accurate, current and complete information about you as prompted in the Site account details section and 2) maintaining and promptly updating account information to maintain its accuracy, currency and completeness.

4. Ordering process

The ordering process happens as follows: you upload your model you would like to be reproduced by Jellypipe; you choose the material, color, surface and size of the model (pay attention, the thickness must be sufficient; you will find instructions on this respect during the ordering process); you choose the country where the model must be delivered; you have a view of the order and the costs

(production, delivery, and other taxes when applicable); you choose the payment manner and execute the payment and confirm the order. Before paying, you have the possibility to go back in the process (clicking the “back” button) if you see that a mistake has been made and you would like to modify it.

You must ensure that the information you submit in your order is accurate and complete before paying it, because afterwards it is impossible to bring any modification because the production starts immediately. Should it not be the case, modifications will be allowed in so far it has been agreed by Jellypipe in writing.

When you place an order, you make a binding contract with our production partner upon our acceptance of your offer as per these terms and conditions. After you have placed an order, we will send you an e-mail confirming your order details. This confirmation means that a binding agreement exists between us, except if your offer is based on a file which contains two or more models “grouped models” (“grouped models”-> our online prizes are only valid for files with individual models) in which case there is no binding agreement between us. The reason for this is that, in addition to printing costs, each model will incur processing costs that depend on the model and the material chosen. Some people see this as a way to trick the price system, as the processing costs are calculated only once and includes all models in one file. While this may seem like a good way to save money, there are some risks involved or if there is an inability to process orders, which you shall be informed at last within two working days after filing your order.

Jellypipe may, at any time during the quotation and the ordering and the manufacturing process, revoke and/or cancel any quotation/order, if there are technical reasons to do so. In such case, Jellypipe will reimburse you all monies paid (less any transactional third party costs, if any).

Jellypipe acts according to its mission, which is to make the world a better and healthier place to live. Therefore, Jellypipe reserves the right to refuse at its own discretion and at all times an order that is in conflict with its mission and value statement. Creating firearms, their components, or any other prototype or model intended for the weapon industry, or models for which Jellypipe has ethical concerns in general, are rejected to be quoted or produced. Jellypipe reserves the right to discontinue the execution process of those orders.

You expressly acknowledge that Jellypipe is not in the position to act as a medical professional. The product that was ordered must not be used in any way for the diagnosis or treatment of disease or in surgery.

The prices, charged upon placement of the orders, are calculated based on building types with a certain attainable level of detail. Due to technical reasons, it may be impossible for certain models to be produced in the requested material-surface-color-quantity combination. In such cases, Jellypipe undertakes best effort to contact you. In any case, Jellypipe then reserves the right to either build the part with a different thickness and/or switch to another production technique, and apply any modification to the order (such as modification of price, of terms/term of delivery, etc.) resulting from such decision. Jellypipe shall not share your uploaded design file with third parties, unless for production reasons.

Jellypipe maintains records of orders and allow you to have access to it for an indefinite period. Jellypipe recommends that you keep a printed copy of these terms and conditions as well as a copy of the order confirmation and invoice.

5. Price - Payment

The price calculated by Jellypipe contains the cost for the services rendered by Jellypipe, the manufacturing of the product and the shipment of the product, as well as taxes when applicable. There is no insurance. Other duties and taxes applicable for the delivery of the product, even if not mentioned in the invoice sent by Jellypipe, will be paid by you.

The price is calculated in EURO, U.S. DOLLARS or CHF (as indicated). Offsetting against any kind of non-approved counter-claims as well as execution of right of retention of goods shall be excluded unless established in court, undisputed or recognised by Jellypipe. Jellypipe remains the sole owner of the products until full payment has been made, transport and taxes included.

Separate parts of a quote can be invoiced separately. Jellypipe AG reserves the right to refrain from execution of further components of a quote, or of a following quote, or to terminate a delivery, as long as the outstanding issued invoices remain unpaid.

6. Terms of delivery – Risk of transport

The average time required to produce the model is about 10 working days. This is a preliminary indication, but does not bind Jellypipe in any way. The actual delivery time is determined by a number of circumstances, for example (but not limited to) working conditions applicable at the time the agreement is concluded, on the punctual delivery of the materials ordered by Jellypipe for the execution of the order.

Should your payment details be incorrect, the delivery will be postponed until the correct information is received from you.

Jellypipe uses its discretion in selecting a reputable carrier and appropriate means of delivery. Risks and benefits pass on to you at the point in time when the products are handed over by us to the transport carrier. All risks during transport are borne by you.

7. Inspection - Returns – Replacements – Refunds

As the products are made immediately on the basis of your specifications, there is no right to return or possibility for cancelling your order within a certain period of time.

Upon delivery of the product, Jellypipe expects that you submit the product to a thorough inspection. If, upon inspection, you feel that the product is not in conformity with the order, you should contact us as soon as possible and at the latest 14 days after your receipt of the product. In case that you fail to exercise this control and/or decide to use a non-conform product, you forfeit any claim(s) you may have against Jellypipe with regard to the product(s).

You should not return products without having received an explicit request from Jellypipe to do so.

Jellypipe reserves the right to revoke and/or modify (part of) a quotation and/or order confirmation for technical reasons.

Your only remedy in such a case shall be a refund of the price of such product paid by you (less any transactional fees) against the return of the product (“Wandelung”). For all disputes arising out of or in connection with the sale of products, the ordinary courts in the city of Zurich shall have exclusive jurisdiction.
