REPORTING DEADLINES

Clinical, HAI, PC-01:	Quarterly submission
HCP Measure:	Annual submission by the May 15, 2020 deadline.
Population & Sampling for Chart-Abstracted Measures:	Quarterly submission
HCAHPS:	Quarterly submission
eQMs:	Submit one quarter's worth of data for four eQMs by the March 2, 2020 deadline.
DACA:	Complete the Data Accuracy and Completeness Acknowledgement between April 1 – May 15, 2020.
