Magdeburg/Merseburg, 30.11.2018 - bmp Ventures AG ("bmp") and a renowned business angel are jointly investing in Robin Data GmbH ("Robin Data"), a spin-off of the Department of Economics and Information Sciences at Merseburg University. Robin Data develops software for the implementation of data protection management. The company receives a low sevendigit amount of fresh capital, primarily from the IBG Risikokapitalfonds III ('IBG') of the Land of Saxony-Anhalt managed by bmp.

Why Robin Data

Prof. Dr. Andre Döring, Dean of the Department of Economics and Information Sciences at the Merseburg University of Applied Sciences, is the creator and co-founder of Robin Data. He is professor for business informatics and project management, as well as a proven data protection expert and management consultant. The co-founder is the experienced IT project manager Daniel Ramsch, a graduate of the Faculty of Economics and Information Sciences and a long-standing employee in IT companies.

Under the motto "Smart Data Protection", Robin Data is developing an intelligent software solution that enables freelancers and self-employed persons, as well as companies and start-ups and public authorities to implement the increasing requirements of data protection independently, digitally and in compliance with the law. Robin Data significantly reduces the



administrative workload of data protection officers and saves time for the actual data protection analysis and consultation at the customer's site, thus reducing mutual liability risks.

What Robin Data can do

"The EU General Data Protection Regulation (GDPR) introduced this year, the forthcoming ePrivacy Regulation and the requirements for the GDPR pose major challenges for many smaller organisations in particular. We now bring together both practical and academic experience and develop our software solution "Robin Data" which enables individuals and organizations to easily understand and comply with the legal requirements of the GDPR. Our customers are also supported by Robin Data in the permanent tasks of data protection", explains Prof. Dr. Andre Döring, who will lead the company as managing director.

Previous solutions are often very complex and can therefore only be operated by specialists - here lies the market potential to create a solution to independently implement the legal requirements of data protection. "We understand data protection as a management system. This is further developed over time by a company. This is where our software comes in: when setting up a data protection management system, the customer can concentrate on the essentials and quickly achieve successful implementation thanks to supporting assistance systems. Robin Data's concept is thus fundamentally different from existing solutions on the market. This is made possible by combining extensive practical and theoretical experience in data protection with state-of-the-art software technology and machine learning," says cofounder Daniel Ramsch.

During the spin-off, the company received active support from the HoMe Gründerservice of the Merseburg University of Applied Sciences. "The promotion of business start-ups is an essential component of our university strategy. We are pleased to have been able to support another outstanding start-up project with Robin Data. This underlines our claim to be a strongly transfer-oriented university," says the rector, Prof. Dr. Jörg Kirbs.

"The issue of data protection is becoming more important for all organisations. We therefore see considerable opportunities for a solution with which data protection can be implemented independently. Robin Data will use the IBG Fund venture capital we provide for software development and market launch," said Jannis Friedag, Investment Manager at bmp. Dr. Jan Alberti, CEO of bmp Ventures AG, adds: "The underlying technology, experience and commitment of the team have convinced us. We are pleased to welcome this university spinoff to our portfolio."
