## Ameritas Fixed Account Guaranteed Minimum Interest Rate Changing After July 5, 2020

Effective with contracts issued on or after July 6, 2020, the guaranteed minimum interest rate (GMIR) on the Fixed Account for FlexMark Select<sup>®</sup> and IncomeMark Select<sup>™</sup> fixed index annuities from Ameritas Life Insurance Corp. will never be less than 0.25%. This change will apply in all states except Florida, Illinois, Vermont, and Virginia (which will continue to provide a 1% GMIR) and does *not* impact contracts issued before July 6, 2020, or any product features.

To receive the current Fixed Account GMIR rate, all premium and requirements must be received by Ameritas Life Insurance Corp. **by 5 p.m., Central time, Friday, July 3, 2020**.
