About the Position

The Financial Claims Analyst will report directly into the Director of Finance and will support financial and project reporting and analysis. Working closely with the Projects team, they will be responsible for the review and processing of project claims and the preparation and reconciliation of Government funding requests. This role will actively engage with staff at all levels to ensure smooth operations, solid internal controls and achievement of company objectives.

This full-time position is Toronto based with occasional travel to Hamilton.

Responsibilities:

- Support the financial aspects of projects by:
 - Reviewing and substantiating project budgets and claims, auditing documentation against funding rules;
 - Preparing project disbursements and initiating the transfer of funds;
 - Processing all financial transactions relating to projects;
 - Preparing and maintain project funding templates, dashboards and processes.
- Supporting the Government Advance and Reconciliation process by:
 - Preparing and submitting quarterly funding requests;
 - Reconciling quarterly spend to amounts advanced;
 - Maintaining and providing documentation to corroborate spend.
- Support other financial reporting and analysis by:
 - Maintaining a strong financial and internal control environment;
 - Reconciling accounts by collecting and analyzing account information and discrepancies;
 - Contributing to the year-end audit;
 - Supporting leadership with other aspects of financial processes, analyses and reporting as required;
 - Contributing to a team effort.
