PET POLICY FORM

The Inn at Fox Hollow has established a Pet Policy that will help ensure the comfort and well-being of all our guests. We know that our pet owners love their pets and want what is best for them; however, the Hotel also wants to ensure that all of our guests have the very best experience throughout their stay with us. The Pet Policy has been created keeping all of the Hotel's guests in mind. We believe that our Pet Policy is not only fair but very practical. The Pet Policy must be strictly adhered to. The Pet Policy is as follows:

- 1) The only pet the Hotel will allow is a dog.
- 2) All pets must be registered upon making a reservation and at check-in. Guests that do not register their pet(s) are subject to a \$500.00 penalty
- 3) The dog must not weigh more than thirty (30) pounds and only one dog is permitted per suite.
- 4) All dogs must have a pleasant and friendly disposition toward people and other animals.
- 5) The dog cannot be a disruption to guests and/or Hotel's staff members.
- 6) There is an initial \$150.00 non-refundable fee for dogs and a \$15.00 per night charge (added to the guests room) for the duration of the guest's stay.
- 7) Additional fees are charged to pet owners for the deep cleaning of the suite and for the housing of the dog.
- 8) In addition to the fees mentioned above, guests are financially responsible for any and all damage caused by their pet.
- 9) Dogs must be kenneled in the suite while the guest is out of the room.
- 10) Housekeeping is not permitted to enter a suite if a pet is not kenneled. Housekeeping must be able to enter a suite at least once every other day.
- 11) Dogs are not allowed in the Hotel's common areas at any time. This includes the Hearth Room, Suite Shop, Buffet Area, Meeting Rooms, Lounge Areas and the entire Courtyard, which includes the swimming pool area.
- 12) The designated dog walk area is in the "back" of the Hotel along the wall of the parking lot.
- 13) In accordance with New York State law and hotel policy, pet owners are responsible for the sanitary clean-up and disposal of their dog's waste. Please clean-up after your dog. Per owners that do not comply, may be charged by the Hotel up to \$50.00 per offense.
- 14) The Inn at Fox Hollow reserves and maintains the right to discontinue the stay of any guest that does not adhere to our Pet Policy and/or if the Hotel finds the pet to be a disturbance in any way.
- 15) Pet owners are responsible for any and all loss or room revenue due to their pet's behavior.
- 16) The Hotel and its entire staff are not responsible for the well-being or behavior of any guest's pet. Guests may not ask Hotel employees to care for their pet in any way under any circumstances.
- 17) The guest assumes full responsibility for any and all actions of their pet (i.e. dog). This includes any and all damage done to the Hotel's property (including outdoors) and of course to the Hotel's guests.

** The Hotel reserves and maintains their rights to revise, change, amend or discontinue their Pet Policy at anytime without prior notification.
