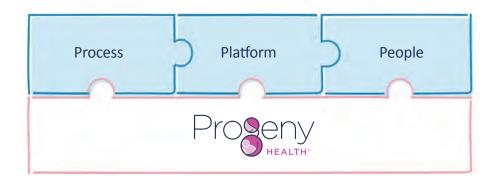

Payment Integrity Solutions



Put your NICU billing and payment accuracy concerns to bed with our Claims Review and Integrity of Billing Service (CRIBS). With auto-adjudication of claims, the claim amount paid is often not known until after payment has been made to the hospital. Most claims processing systems lack the logic required to review and reject claims that don't match the length-of-stay and levels-of-care authorized by the medical management staff or vendor.

Our service enables post-adjudication, pre-payment verification of coded charges and levels based on our clinical authorizations and expected claim outcome. And it completes the process proactively, within your crucial TAT targets, helping to improve these NICU cost drivers:

- ✓ **Length-of-Stay**—by verifying number of days billed vs. authorized
- ✓ Level-of-Care—by assuring the billed charges match the clinical levels-of-care authorized
